1. CALL TO ORDER

The regular meeting of the City Council of the City of Darien was called to order at 7:30 P.M. by Mayor Weaver.

2. PLEDGE OF ALLEGIANCE

6. RECEIVING OF COMMUNICATIONS

Alderman McIvor has received a telephone call and several e-mails from a resident of Farmingdale Village, Jim Devitt, who lives on Ailsworth Drive which is adjacent to a new commercial development which has been under construction for approximately six years. The commercial development, which is on the west end of Farmingdale Village, was annexed by Woodridge and rezoned from single family residential to commercial. The lighting from the hardware store at this new development is creating a problem for the residents. The lights, which are on all night, shine in the residents' back yards. Dan Gombac is working with the residents and Woodridge in an attempt to resolve the situation. Residents in the affected area are encouraged to contact Woodridge officials regarding this problem. Dan Gombac will continue to pursue options for relief with Woodridge. Per Attorney Murphey, although the City of Darien has no recourse, the individual residents could bring a civil suit, if the problem is not resolved.

9. CITY ADMINISTRATOR'S REPORT

Administrator Vana had nothing to report.

10. DEPARTMENT HEAD REPORT

Community Development/Public Works Director Daniel Gombac provided informational updates as follows...

- ...reviewed the City's snowplowing equipment, crews, and the steps taken when there is a snow event.
- ...reminded residents to please check their mailboxes for structural integrity. Items to look for are rusted or rotted wood bases at the ground level, as well as rusted or deteriorated fasteners holding the mailboxes to their supports. In the event a mailbox is inadvertently knocked down during snow removal operations, residents should contact the Public Works Department. A temporary mailbox will be installed until the repairs of the existing mailbox can be completed. The city plows approximately 70 lane miles with 149 cul de sacs. The city recently obtained a new piece of trackless snow equipment for plowing of the approximate 21 miles of designated sidewalks throughout the city.
- ...the Clarendon Hills Road bicycle path project has been completed. Maintenance for the path has been turned over from DuPage County to the City of Darien.
- ...provided an update on the proposed Safe Routes to School Program. The IDOT Implementation Committee has recently completed their review and has forwarded their recommendations to IDOT management. A time frame of the finalization process has not been determined.
- ...True Value will be opening a new store in Brookhaven Plaza. Opening is tentatively scheduled to take place in January.
- ...residents were reminded to replace the batteries in their smoke and carbon monoxide detectors. Carbon monoxide detectors have a shelf life. When replacing the batteries, the expiration date on the back of the detector should be checked. Carbon monoxide detectors are to be installed within 15 feet of sleeping quarters.
- ...over 100 intersection street signs have been replaced. Residents may go to the City of Darien website to learn when their street name sign is targeted to be installed.

Mayor Weaver advised that the sign at 67th & Western looks like the top was chipped off.

Dan Gombac advised that some of the signs need to be reinstalled. Mr. Gombac informed the Council members of vandalism of the new street sign at 69th & High. Residents were urged to contact 911 if they view any suspicious behavior.

Alderman Poteraske noted that sometimes it is difficult for the snow plow drivers to differentiate between the curb and the street. Installing the new police reflectors at the curbs and streets prior to the snow fall would be helpful.

Dan Gombac responded that a dry run of the snow routes is planned and obstacles will be noted at that time.

Alderman Poteraske inquired if the city will be budgeting for crack filling on the bicycle path. Cracks are developing on 75th going west on the north side of the street.

Dan Gombac will research whether this area is the responsibility of the City of Darien or DuPage County.

Mayor Weaver advised that there are twelve liquor license classifications. Seven of the twelve allow for an extension. The type of business determines whether the extension is allowed. A thorough review must be conducted prior to changing the current ordinance.

Administrator Vana announced that, due to the holiday, refuse which is normally picked-up on Thursday will be collected on Friday, and Friday's refuse will be picked up on Saturday.
