1. CALL TO ORDER

The regular meeting of the City Council of the City of Darien was called to order at 7:30 P.M. by Mayor Weaver.

2. PLEDGE OF ALLEGIANCE

Mayor Weaver led the Council and audience in the Pledge of Allegiance.

3. ROLL CALL — The Roll Call of Aldermen by Clerk Coleman was as follows:

- 5. APPROVAL OF MINUTES September 17, 2007

6. RECEIVING OF COMMUNICATIONS

Alderman Galan reported the results of the animal control survey of neighboring communities found that most municipalities do not handle feral cats. The responsibilities generally fall to the homeowner.

Alderman McIvor advised that there are companies that trap feral cats, have them spayed or neutered, and then release them. This process stops the cycle of reproduction. Names of companies, which perform this service, are available through the West Suburban Humane Society.

Mayor Weaver pointed out that, if desired, this issue would have to be reviewed during the budget process. She suggested that information on the service Alderman McIvor mentioned be placed on the City's website.

Administrator Vana stated he did some research on feral cats. Through his research, it was found that feral cats do not attack small children but do provide rodent control benefits.

Mayor Weaver received an e-mail from Kathy Mullaney expressing concern with the safety of walkers and runners on city streets rather than on the sidewalk.

Alderman Poteraske stated he has received telephone calls from residents in regards to Argonne. Scott Coren will be providing an update on this issue this evening.

7. MAYOR'S REPORT

Mayor Weaver...

...read into the record a Proclamation declaring the first week of October as "Fire Prevention Week," and October as "Fire Safety Month" in the City of Darien.

... read into the record a Proclamation declaring October 12 and 13, 2007 as "Lion Candy Days" in the City of Darien.

Dale Schaefer of the Lions Club was in attendance to accept the Proclamation. Mr. Schaefer commended the outstanding collaboration between the City of Darien and the community service organizations.

8. CITY CLERK'S REPORT

City Clerk Coleman...

...announced that the Public Works Water/Streets Committee Meeting has officially been changed to the third Monday of each month. The next meeting is scheduled to take place on Monday, October 15, 2007.

...advised that in response to the Violet Farm partial demand resolution passed by the City Council on September 5, 2007, a check in the amount of \$32,162.32 was received.

...requested the Administrative and Finance Committee review and update the current Solicitation regulations.

...reminded all that the vehicle sticker lottery will take place at the October 15, 2007 Council Meeting.

9. CITY ADMINISTRATOR'S REPORT

Administrator Vana...

...noted that the residents are getting accustomed to the Neighbors of Darien magazine. The delivery rate is not at 100%. The City has requested a credit for the magazines that were not delivered to the residents. The publisher will monitor the delivery of this publication. The new magazine is released approximately one week prior to the two months that it covers. If residents do not receive their copy, please notify City Hall.

10. DEPARTMENT HEAD REPORT

Assistant to the Administrator, Scott Coren...

- ...announced that the City Council meetings may now be viewed on demand through the City's website.
- ...reported that Amnesty Week was very successful. Two hundred twenty-six (226) tons were collected. This represents fifty-six tons more than last year.
- ...Electronic Recycling Day was also a very successful event. Two hundred and eleven computers were collected.
- ...ComEd replaced 13,335 feet of underground cable over the summer. This is in addition to the more than 5,000 feet of cable replaced as part of the lawsuit. Underground cables at Farmingdale Village and Marion Hills need to be replaced. The city is pursuing this with ComEd. There have been no outages where cable has been replaced. ComEd provides a seven-day advance notice for planned outages. If this is not possible, they utilize automated telephone notifications.

...Clarke Mosquito recently completed their treatments for mosquitoes for the 2007 season. More calls and questions were received this year due to heavy rainfall throughout the summer.

...at the request of Alderman Marchese, Mr. Coren explained that the City has moved away from mosquito spraying to larvicide treatment for health reasons. The City has found that treating the larvicide is much more successful, without the adverse effects of spraying. Residents were encouraged to help reduce mosquitoes in the area by refilling birdbaths on a regular basis, and making sure water flows properly from gutters and sump pumps to storm sewers.

...AT&T is currently in the process of rolling out "Project Lightspeed." This will provide a competitor to Comcast for video, high speed Internet, and telephone services. The State of Illinois has granted AT&T the ability to deliver video service to residents. The program is expected to take off in February or March of 2008.

...in response to Alderman Galan, Mr. Coren advised that the city has to accept AT&T under certain terms. Additional landscaping around the AT&T boxes can be acquired if necessary.

...in response to Alderman Marchese, Mr. Coren advised that the city will not be receiving a lump sum payment from AT&T

Mayor Weaver stated service from Comcast may improve with competition from AT&T. Comcast needs to improve the condition of their cable boxes. The ones at 75th and Cass and the one near 79th are rusted and in terrible disrepair.

Alderman Marchese noted that AT&T is very responsive to concerns about the condition of their equipment.

Alderman Galan questioned whether there would be any relief from AT&T for costs to the city.

Scott Coren replied that there would be some relief but not large amounts. Revenues will remain as they are but not improve. There will be no benefit to the city from the Internet service.

Alderman Poteraske commented that the Electronic Recycling Day was handled very well.

Mayor Weaver advised that it is uncertain if this will be an ongoing activity.

Scott Coren stated that this event is very labor intensive with associated costs.

He also announced that Argonne Laboratories has extended their comment period. A list should be forthcoming in approximately four weeks.

Mayor Weaver questioned how the new telephone system is fairing.

Administrator Vana advised that there was a very smooth transition, and that the vendor has provided excellent support.

Scott Coren noted the city has already seen a reduction in the telephone bill.
