## 1. CALL TO ORDER

The regular meeting of the City Council of the City of Darien was called to order at 7:30 P.M. by Mayor Weaver.

## 2. PLEDGE OF ALLEGIANCE

... commented that a Public Hearing was held prior to the Council meeting in regard to the proposed 2006-2007 Budget, which the Council would vote on under New Business. He thanked Council and staff for their hard work.

Police Department Chief Robert Pavelchik reminded residents to be careful and cautious with their personal property. He indicated that due to the nicer weather crime had increased. He indicated that most were crimes of opportunity due to open garages, unlocked cars, unattended purses, and stolen cars with keys in them.

Public Works Water/Streets Committee — Chairman Biehl submitted, for the record, Minutes for the Rescheduled March 6, 2006 meeting. He noted that there were two items on the Consent Agenda that the Committee recommended for approval.

## 13. QUESTIONS AND COMMENTS — AGENDA RELATED

Pricilla Rodriguez, 1418 Plainfield Road, spoke in opposition to the rezoning of the property at 1422 Plainfield Road. She indicated that they moved to Darien in 2001 and were in the process of constructing an addition to their single-family home. For the record, she asked for the right to respond to any comments the petitioner may have to say to her, her husband, or her family.

Jose Rodriguez, 1418 Plainfield Road, spoke about a comment made to Mr. Appavu, which was that he did not care; Mr. Rodriguez said that he did care, was building his dream house, and intended to live in it for a long time.

Ron Snyder, 7838 Pine Parkway, thanked Council for listening and hearing the residents' perspective on the rezoning issue. Mr. Snyder said that he was President of the Pine Parkway Homeowners Association, which included 25 families; they adamantly opposed the rezoning of the 1422 Plainfield Road parcel. He spoke about Darien's growth and the intent of the Comprehensive Plan as it had been updated. He asked if the project was in the best interest of the City and all of its residents.

John McPherson, 7818 Pine Parkway, spoke about the good that existed within the community and hoped that the residential value would increase because of demand. He asked that Council vote 'no' to the rezoning of the parcel at 1422 Plainfield Road.

Barb Jones, 7802 Pine Parkway, indicated that she attended all three of the meetings regarding 1422 Plainfield Road. She said that the 'karma' of the community was the result of the collective consciousness of businessmen, residents and political leaders. She indicated that rezoning of the parcel would allow for the eventual construction of another office building. Ms. Jones commented that the definition of 'comprehensive plan' was broad, general and sweeping and that it was not exact, detailed or specific. She asked that Council have a grasp, a grip, an understanding and that there was no fault in rethinking a broad plan.

Mary Burdich, 1421 77th Street, stated that rezoning 1422 Plainfield Road would impact her property. She asked that Council oppose the rezoning.

Andrew Spiegel, Chawla Group, representative of the current owner of 1422 Plainfield Road; he said they were requesting a reduction to the number of required parking spaces from 10 to 5 in order to maintain its residential appearance. He said that the petitioner would use the property in its current configuration, was not going to demolish or build a two-story office building. Mr. Spiegel noted that if the parcel was rezoned to Office that the owner would willingly volunteer to add as a condition to the rezoning that the property would stay in its current configuration and that there would be no redevelopment by the petitioner while on the property without further public hearings.

Aramudhan Appavu, 909 79th Street, spoke about why he chose to live in Darien. He indicated that prior to purchasing 1422 Plainfield Road that he spoke with staff and reviewed the Comprehensive Plan; he signed the purchase contract in September 2005; and he followed procedure for rezoning. He indicated that he had no intention to change the structure, would comply with the landscaping requirements, and requested less parking.

Leonard Ouski of Homer Glen stated that Medicare Home Health Care Guidelines stipulated that a home/health office could not be within a residential home.

Steve Bonfield, 7831 Pine Parkway, suggested a special use variation to allow Mr. Appavu three additional parking spaces without rezoning the parcel, which was not acceptable.

B. CONSIDERATION OF A MOTION TO APPROVE AN ORDINANCE APPROVING A REZONING FROM THE R-2 SINGLE-FAMILY RESIDENCE DISTRICT TO THE O OFFICE DISTRICT AND A VARIATION TO THE DARIEN ZONING ORDINANCE (PZC 2005-23: 1422 PLAINFIELD ROAD)

It was moved by Alderman Marchese and seconded by Alderman Weaver to approve an Ordinance Approving a Rezoning from the R-2 Single-Family Residence District to the O Office District and a Variation to the Darien Zoning Ordinance (PZC 2005-23: 1422 Plainfield Road), as presented.

Attorney Murphey explained that the Comprehensive Plan was a guideline; the Comprehensive Plan did not 'trump' the Zoning Ordinance. He spoke about the restriction imposed by an agency other than the City; the City has a Home Occupation Ordinance that would allow individuals to utilize their property in addition to residential use for a business, which would have low impact and no indication of business activity. Attorney Murphey noted that the Ordinance before Council did not contain a reverter clause; the Ordinance did not contain language for a land use to a land user. He said that by rezoning the property, the Council agreed that the transformation of the land use from residential to office classification was appropriate. He addressed the comment about the parking variation; he indicated that it did not answer the basic question outlined in the petition, which was to change the land use; the variation would simply change the parking.

Alderman Marchese spoke about office space within the City of Darien. Mayor Weaver submitted, for the record, a letter from Alderman Durkin in regard to 1422 Plainfield Road.
