Per Alderman Galan's request, Administrator Vana provided a detailed explanation of the decision not to abate certain taxes this year. Administrator Vana noted that the increase in the assessed value of properties was a major factor in the rise in taxes. The city's portion of the tax bill amounts to just 3.1% of the property taxes.

Alderman Marchese clarified that the city did not abate the tax this year in order to make sure there were cash reserves for capital improvements such as the road repair and ditch projects.

Alderman McIvor added that the Council Members felt that it was appropriate not to abate the taxes this year in order to maintain a healthy fund balance.

Administrator Vana noted that the city's tax rate is the fourth lowest in DuPage County.

Alderman Marchese stated that residents are provided excellent services at economical costs. Alderman Marchese asked residents not to confuse the city taxes with those of the other taxing districts.

Treasurer Coren added that the city's fund balance and excellent rating are the reasons good interest rates are attainable.

Mayor Weaver noted that although District 66 has not attended any of the meetings, they have always been invited to participate, and the invitation remains open.

Alderman Schauer thanked everyone for their support, and looks forward to working with City Council and Staff.

Jerry Falasz of 1641 73rd Street congratulated the new and re-elected aldermen. Mr. Falasz thanked the City Council and staff for their explanation of the tax increase and recommended this explanation be provided on the city's website.

Greg Krcmar of 2200 Green Valley Road asked if the new development area will be a TIF District.

Mayor Weaver responded that it will not be a TIF District.

Mr. Krcmar commented that he is on a fixed income and would prefer that taxes be raised minimally on a yearly basis rather than a large increase at one time.

Administrator Vana reiterated that the tax increases were largely due to an increase in the assessed values.

Treasurer Coren informed residents that they have thirty days from notification by the Tax Assessor's Office to object to their assessed valuation.

Alderman McIvor advised that her attempt to object to the assessed valuation was rejected.

Administrator Vana clarified that the repayment amount of the bond issue is consistent, but noted that the Police Pension is funded by the tax levy as well. An actuarial study is performed annually to determine the Police Pension cost. Administrator Vana noted that the city has been fortunate in being able to continue to perform yearly improvement projects, at excellent pricing due to the current economy.

Treasurer Coren urged senior citizens to contact the Downers Grove Township Tax Assessor's Office to take advantage of any exemptions offered.

There being no further business to come before the City Council, it was moved by Alderman McIvor and seconded by Alderman Gattuso to adjourn.
