Minutes of the Regular Meeting of the City Council of the CITY OF DARIEN NOVEMBER 5, 2007

1. CALL TO ORDER

The regular meeting of the City Council of the City of Darien was called to order at 7:30 P.M. by Mayor Weaver.

2. PLEDGE OF ALLEGIANCE

Mayor Weaver led the Council and audience in the Pledge of Allegiance.

6. RECEIVING OF COMMUNICATIONS

Alderman Marchese submitted for the record a letter with associated drawings from Michael and Helen Mark, residents of 2300 Oakmont Way expressing concern with the lack of lighting at the east and west entrances to Waterfall Glen Condominiums off South Frontage Road.

Dan Gombac said he will contact ComEd and IDOT to see what can be done to rectify this issue.

Alderman McIvor reported she received many calls yesterday morning regarding the water main break in Farmingdale Village. Alderman McIvor commended the efforts of Public Works in handling this main break. Alderman McIvor urged residents to contact the non-emergency number at the Police Department at 630-971-3999 to report or obtain information on these types of events.

Alderman Poteraske was happy to advise that, per a letter to Mayor Weaver from Argonne, two of their nuclear laboratories are being permanently closed.

Alderman Avci mentioned he received communication from Mr. Greg Vogt, a resident residing on Seminole Drive, regarding the "No Left Turn" signs installed on Seminole and Plainfield Rd. This item will be placed on the Administrative/Finance Committee Meeting Agenda of December 10, 2007 for review and discussion. It is anticipated that Mr. Vogt, as well as other area residents, will be in attendance at that meeting.

Alderman Galan was contacted by Mr. Ordzowaly of 525 70th Street regarding his satisfaction with the resolution of a drainage problem. Alderman Galan felt the resolution could not have been achieved without the involvement of Dan Gombac.

Alderman Galan noted being contacted by Gary Roth, a resident on Elm Street, regarding a drainage problem on Sunrise. Alderman Galan and Dan Gombac will meet with Mr. Roth to review the situation.

He also received a letter today from Tami Hollendonner of 7117 Crest Road on behalf of herself and the five homeowners on Crest Road requesting some type of barrier, such as a tall fence or large landscape material, to isolate the homeowners from the lights and commotion at the new shopping center across Route 83.

Dan Gombac said he will contact the developer to see if some consideration can be made for the residents on Crest Road. The developer's response will be brought back to the City Council.

Mayor Weavor reported being in receipt of a copy of a letter addressed to Carmen Molfese from a Claims Adjuster at ComEd regarding service irregularity, which occurred on August 18, 2007. Despite ComEd's admission that cable failure caused the damaged microwave, the claim was denied. This information will be provided to Scott Coren for follow-up.

...read into the record an e-mail from Don Bulat of 121 Holly Avenue expressing gratitude to the City Council and recognizing Dan Gombac for his efforts in fixing the sewers in his neighborhood.

...attended the opening of the University of Illinois Extension. Mayor Weaver was very impressed with the numerous programs offered and requested that a link to the University of Illinois Extension be placed on the City's website.

Bryon Vana advised that this will be mentioned on the City's cable station as well.

A. Greg Weider, Executive Director of the DuPage Senior Citizens Council presented a Certificate of Appreciation to Mayor Weaver. Mr. Weider noted that the City has been a valued partner and thanked the Council Members for their continued support.

Mayor Weaver will present the Proclamation to Bradly Bucholz at the Veteran's Day assembly at Lace School on Friday, November 9, 2007.
