## 6. RECEIVING OF COMMUNICATIONS

Alderman Biehl received many complaints about the snowplowing within his Ward. He commented that "somebody fell asleep on the job this time" and that the crews should have been called out earlier. Alderman Durkin agreed with Alderman Biehl; he requested a report on plowing procedures. He noted that Cass Avenue within Westmont was in excellent condition compared to Darien.

Alderman Weaver commented that Cass Avenue and other major streets within Darien were under the jurisdiction of DuPage County for plowing. She noted Darien had requested permission to plow Cass Avenue, however DuPage County threatened a lawsuit should we plow roads in their jurisdiction. She said that the County should be contacted about their procedures.

Administrator Curneal said that a presentation regarding snow plowing procedures was a good idea. He

said that he would contact County regarding their procedures.

Mayor Soldato said that Cass Avenue was a disaster. He asked that the policy for plowing cul-de-sacs be revisited and that safety sidewalks needed to be shoveled/plowed when streets were plowed.

City Clerk Coleman ...

- ... commented that City office would be closed on Monday, February 18th, in observance of Presidents Dav.
- ... noted that the next City Council Meeting would be held on Tuesday, February 19th, due to the Presidents Day Holiday.
- ... announced that a Special Meeting of the City Council would be held on Monday, February 11th, at 7:30 P.M. to discuss economic development.
- ... invited everyone for coffee with Mayor Soldato on Saturday, February 16th, from 9:00-10:00 A.M. in the Darien City Hall Council Chambers.
- ... stated that the Plan Commission meeting scheduled for February 6th and the Zoning Board of Appeals meeting scheduled for February 12th were cancelled due to lack of agenda items.
- ... said that the close for Voter's registration was Tuesday, February 19th, for eligibility to vote at the March 19, 2002 Primary Election.
- ... received notification from the DuPage County Election Commission that any civic organization and proponents/opponents of propositions that are on the March 19th ballot should register with the Election Commission prior to February 7, 2002 in order to obtain pollwatcher credentials.

Administrator Curneal reminded Council of the scheduled Administrative/Finance Committee-of-the-Whole budget meetings, which are to be held on February 26, March 5 and March 12.

#### 10. DEPARTMENT HEAD REPORT

Police Chief Edward Musial ...

- ... commented that the Department recently completed a tobacco/cigarette compliance check. There are twenty-one businesses that sell tobacco within Darien. Six businesses failed to comply; three did not ask for identification and three, after checking identification, sold to a minor. All six were cited. The Department scheduled a training seminar with the State of Illinois and all businesses in regard to compliance/regulations, which will be held on February 21st at 2:00 P.M. in the Council Chambers. ... stated that street parking continues to be an on-going problem at Hinsdale South High School. He said
- ... stated that street parking continues to be an on-going problem at Hinsdale South High School. He said that a questionnaire was sent to residents and some have responded, the deadline for response was set for February 15.
- ... noted that the Department was over budget due to overtime, which resulted from officers recovering from various surgeries and/or injuries, plus other outside details.

Alderman Weaver inquired about the Hinsdale South High School parking at 74th Street and Elm. Chief Musial responded that "NO PARKING" was posted on Elm from Route 83 to the High School, 74th Street was posted, and Eleanor was posted on the east side between 74th and Elm. Permit parking, no parking and damage to parkways in the area were discussed.

Alderman Biehl inquired if tobacco advertising had to be a certain distance from a school. Chief Musial stated that he would investigate.

Alderman Tikalsky asked what the fine was to a business that sold tobacco to a minor. Chief Musial responded that the individual who sold the tobacco was fined, not the business.
