This memo will serve to outline the budget meeting for March 6, 2012. The items to review include:

- budget reduction options in the amounts of \$500,000 and \$1,000,000
- pay classification for the Assistant City Administrator Position
- · review of budget changes to date

<u>The first item</u> for review is the attached sheet showing budget reduction options in the amounts of \$500,000 and \$1,000,000 as requested by the council. Part of this discussion included a concern that no stable funding mechanism exists for funding projects as an alternative to cutting capital projects, the chart below shows the impact on increases to the property taxes that could be applied to capital project funding. I looked at property taxes because:

- the city's tax rate is low as compared to other communities in DuPage County which is shown on the attached survey
- property taxes can be deducted from federal income taxes for those who file itemized deductions
- a specific amount can be levied for capital projects funding and the levy can be abated if other revenue sources become available

In summary, the following shows the increased amount on the individual taxpayer with a home that has a fair market value of \$340,201 and an assessed value of \$115,820.

The second item to review is the pay classification change for the Assistant City Administrator Position. In preparation for the budget each year, staff checks surrounding communities to compare salaries and ranges to ensure compensation is comparable within the local market. In the past, this has led to modifying ranges for several different positions, including secretaries, general utility workers, directors and police administrative staff.

Factoring in both internal and external comparisons, the proposed increase in salary ranges is 2% for all positions except for the Assistant City Administrator. The positional requirements and duties vary depending on the population, staff size and services in many municipalities. For a City the size of Darien, an Assistant that can handle a range of duties including human resources, risk management, information technology and policy analysis is required. Taking into account current responsibilities as well as the comparisons with other local entities (see attached assistant city administrator salary comparison 2012), movement in the salary range from 9 to 15 is warranted. A move to this salary would keep the actual compensation ranked 8 out of 10<sup>th</sup> within this survey. The two lower paid positions in the survey are both Assistant to the Administrator positions, which is considered a lower grade within local governments. This salary range is more comparable to the local market for the second highest administrative position in a community. The actual salary would increase from \$66,472 to \$75,052. The salary/benefits change for the current position would increase by \$10,092, which was included in the draft budget.

<u>The third item</u> is the review of budget changes to date. The attached sheet lists the changes.
