1. CALL TO ORDER

The regular meeting of the City Council of the City of Darien was called to order at 7:32 P.M. by Mayor Weaver.

2. PLEDGE OF ALLEGIANCE

Mayor Weaver led the Council and audience in the Pledge of Allegiance.

6. RECEIVING OF COMMUNICATIONS

Alderman McIvor...

...received a telephone call from David Leatherwood of 1913 Gordon Court complaining about the lack of customer service he has received when calling ARC Disposal & Recycling Company.

...submitted, for the record, a follow-up letter from Mary C. Wurzer of 2971 Meadow Court, with concurrence by residents Ronald Basile of 2990 Meadow Court, and Kathy Kurze and Debra Globis of 2961 Meadow Court, expressing displeasure with ARC Disposal & Recycling Company, Inc. in regards to the requirement for exclusive use of ARC for dumpsters and their charges for same. In addition to the dumpster rental fee, an additional charge for the weight is invoiced. Alderman McIvor requested the Council Members review these issues.

Mayor Weaver suggested that when the contract is up, the weight fee issue be reviewed.

...received an e-mail and Edible Arrangement from Edward Troche thanking the City of Darien, for their help in dealing with damage done to his fence by a landscaper who was doing work in Woodridge.

7. MAYOR'S REPORT

A. Louis G. Karrison of Sikich Professional Services and Support presented and reviewed the audit and management letter. Mr. Karrison and Treasurer Coren answered the questions of the Council Members.

- B. Mayor Weaver read into the record a Proclamation declaring December, 2007 as "Drunk and Drugged Driving (3D) Prevention Month" in the City of Darien.
- C. The City is looking for nominations for the Holiday Home Decorating Contest. The deadline for nominations is December 7. The judging committee will start visiting the nominated homes on December

- 10. The contest award will be presented at the December 17, 2007 Council Meeting. The nominated homes will be visited by the Holiday Lights Trolley Tour after December 17. Residents are welcome to participate in the Trolley Tour.
- D. Mayor Weaver was pleased to announce the kick off of the Darien Intergovernmental Program Initiative. Although it is anticipated that all taxing bodies will become involved, initial discussions will begin with School Districts 61 and 63. The meeting has been tentatively scheduled to take place on December 13. Once the date has been finalized, the public will be notified.

8. CITY CLERK'S REPORT

City Clerk Coleman invited all to attend Coffee with Mayor Weaver on Saturday, December 15, 2007 from 9:00 A.M. to 10:00 A.M. at Carmelite Carefree Village.

9. CITY ADMINISTRATOR'S REPORT

Administrator Vana...

- ...announced that the free leaf pick-up program has been extended one more week ending December 8, 2007. The extension was publicized on cable, direct connect, and on Hinsdale South High School's event board.
- ...tree marking has begun. A green dot means the right of way tree is marked for trimming. A red or orange dot signifies removal of the tree.

Mayor Weaver advised that she received a letter from the Kozlowski's questioning whether the City's name will be placed on the water tower. The water tower will not carry the City's name.

Dan Gombac advised that the water tower was on this morning's Today Show.

10. DEPARTMENT HEAD REPORT

Police Chief Robert Pavelchik...

- ...requested, with the approaching holidays and the increase in traffic, residents be patient and careful when driving. He suggested that residents be aware of their surroundings and keep purses and wallets close at hand. Identity theft occurs more frequently from stolen identification than from the internet. Residents were urged to shred all documents before discarding.
- ...Alive at 25 Program begins this week. Chief Pavelchik and Ralph Menzione received training from the National Safety Council. Alive at 25 Program is a cooperative effort with District 86 High School District. In the future, classes will be scheduled for students who attend other high schools in the area. Class schedules will be posted on the City's website and cable once they have been determined.

Alderman Poteraske requested Downers Grove District 99 be included in this program.

Chief Pavelchik advised that this program is put on through the National Safety Council and that the number of participating communities and school districts is increasing.

In response to Alderman Durkin, Chief Pavelchik advised that with enough notice, a class can be arranged for groups of twenty or more from various organizations.

Alderman Avci expressed concern with vandalism which took place at his neighbor's home. It was fairly evident the culprits were young people. Chief Pavelchik advised that, although these types of activities occur from time to time, they are not prevalent. Mayor Weaver commented that these types of pranks have been escalating and suggested a peer jury at the high school to mete out judgments to these children.

Chief Pavelchik said that it is imperative that parents stay involved in their children's lives.

In response to Alderman McIvor, Chief Pavelchik advised that residents interested in forming a Neighborhood Watch, should contact Ralph Menzione at 630-353-8313.

Alderman Marchese noted that, in the past, there has been a great deal of success with parenting classes and community service programs. He stated that parents need to support schools and law enforcement when necessary.
