#### 1. CALL TO ORDER

The regular meeting of the City Council of the City of Darien was called to order at 7:30 P.M. by Mayor Weaver.

# 2. PLEDGE OF ALLEGIANCE

Mayor Weaver led the Council and audience in the Pledge of Allegiance.

A. Mayor Weaver announced that a letter has been received notifying the City of Darien that Argonne Laboratories has been taken off the list as a possible site for the GNEP Program for nuclear testing.

## 8. CITY CLERK'S REPORT

City Clerk Coleman...

...advised that the Planning and Zoning Commission meeting, which was scheduled to take place on August 6, 2008, has been cancelled due to a lack of agenda items.

...invited all to attend Coffee with Mayor Weaver on Saturday, August 16, 2008 at City Hall in the Council Chambers from 9:00 A.M. to 10:00 A.M.

#### 9. CITY ADMINISTRATOR'S REPORT

There was no report this evening.

## 10. DEPARTMENT HEAD REPORT

Assistant to the Administrator, Scott Coren...

...provided an update on the status of ComEd outages in Darien. ComEd provided the city with outage data for the first six months of 2008. In comparison with the same period in 2007, there were three additional outages in 2008. The increase was due to weather related outages. Underground failures and malfunctions went down slightly due to work the city has had ComEd perform since the lawsuit. Staff has invited ComEd to attend the September 15, 2008 City Council Meeting to provide updated information. Staff will be meeting with ComEd prior to the Council Meeting in order to review the weather related outages, specifically lightening strikes, to see what further work can be done to reduce the amount under those conditions. Circuit inspections and trimming which will be performed soon should help reduce

outages next year. Outages continue to occur in Farmingdale Village and Marion Hills. The city is still waiting to hear whether cable will be replaced in those areas.

...advised that city staff and Website Q&A have been working on website improvements. Website Q&A has added a new search feature which will provide answers to frequently asked questions. Residents will also be able to request city services on-line. Website Q&A is also working on providing internet access to the Council Members in the Council Chambers.

...announced that government access should be available with AT&T Project Light Speed beginning on September 22, 2008.

Mayor Weaver disagreed with ComEd's report that the number of underground faults has gone down. A number of faults occurred in Ward 4, and one circuit in particular seemed to have a good deal of down time.

Scott Coren advised that although many faults continue to occur, the numbers have gone down steadily. Compared with last year, the number of underground faults went down from sixteen to ten. Although progress has been made, the city will continue to pursue improvements from ComEd. Staff will meet with ComEd every six months, and require attendance at City Council Meetings on a regular basis.

Alderman Poteraske commented that W804 continues to be a constant problem. Darien was slightly affected during the last outage, but areas around Darien, which use the same circuit, seemed to have a problem.

Scott Coren advised that W804 originates out of Downers Grove, and is fed from the Lisle substation. ComEd appears to be focusing on providing Darien with the cable improvements. It is evident that ComEd needs to perform improvements in other communities as well as Darien.

Alderman McIvor stressed the need to continue to pursue ComEd repairs.

Mayor Weaver suggested it may be beneficial to bring back the city's consultant, Ken Seaton, to assist in determining where the city's efforts should be directed.

Alderman McIvor agreed that it would be pro-active to have a consultant come in on an annual basis to review ComEd's reports, and put together an action plan.

Mayor Weaver stated that the city would need to seek a proposal from Mr. Seaton.

Administrator Vana suggested it would be advantageous to have Ken Seaton sit in on the initial meeting with staff and ComEd. Administrator Vana added that it would be more productive and informative to have ComEd technical representatives attend the September 15 Council Meeting with Katie Maier.

Alderman McIvor reminded staff to follow up with Comcast on the pedestal on Beller which is in disrepair.

Mayor Weaver added that there is also another pedestal located in front of St. John's Lutheran Church which is also in disrepair.

Staff will look into both.

11. TREASURER'S REPORT

One of the topics at the meeting will be the traffic sign adjustments throughout the city.

Mayor Weaver added that a letter was received from Bonnie Kohout regarding the "No Left Turn" sign at Lyman/Manning Road. Mayor Weaver observed drivers crossing the street, making a U-turn and then turning right.

Alderman McIvor advised that she has also received communications from residents regarding this "No Left Turn" sign. Alderman McIvor suggested that the upcoming meeting be posted on Channel 6 and our website.

Staff will make sure the information is posted on Channel 6 and on the website.

16. NEW BUSINESS

New Business Item A. was moved to the Mayor's Report, and Item B. was moved to the Consent Agenda as Item H.

17. QUESTIONS, COMMENTS AND ANNOUNCEMENTS — GENERAL

Tom Diviscour of 341 Plainfield Road addressed the City Council with concerns regarding a letter he received from the city on the placement of his fence which is located within the flood plain. Mr. Diviscour has been residing at this address for approximately eight years, and the seller lived there for at least ten years. Mr. Diviscour advised that when the culvert fills with water, the excess goes through his property. The fence serves as a strainer, collecting the debris from the culvert, and keeping it from going into the main storm sewer. Mr. Diviscour feels it would be a mistake to remove the fence.

Director Gombac advised that the Illinois Department of Natural Resources identified four properties within Darien which violate the state's codes regarding structures located within a flood way or plain. IDNR sent a letter to the City of Darien mandating compliance. A topographical survey, which would show if the fence is located within the flood way or plain, could not be located. Topographical surveys cost approximately \$1200 per lot. The city has been trying to assist the four residents involved in obtaining a cost share for the topographical survey. Director Gombac warned that the survey may not justify that the fences should remain.

Police Chief Pavelchik announced that a tornado was sited in Westmont and requested the meeting be adjourned as quickly as possible.

Mayor Weaver assured Mr. Diviscour that the city will do their part to try to save the residents money but added that a topographical survey may prove that the fence needs to be removed. Mayor Weaver stated that the city has to adhere to a higher authority in this case.

Mayor Weaver inquired if the boy scouts in attendance wished to address the City Council. They did not.

#### 18. ADJOURNMENT

There being no further business to come before the City Council, it was moved by Alderman Gattuso and seconded by Alderman McIvor to adjourn.
