6. RECEIVING OF COMMUNICATIONS

Alderman Biehl received email and spoke with residents in regard to the Dale Basin. Mayor Soldato stated that a letter had been sent to residents and that comments were being collected by Administrator Vana; he encouraged the Aldermen to view the Basin and share their comments.

Alderman Cotten was contacted by Mary Toniolo in regard to the curb replacement program; she was concerned about the curb on Beller Drive between Parkview Drive and Lemont Road.

7. MAYOR'S REPORT

A. MAYORAL PROCLAMATION "NATIONAL SAFETY MONTH" (Month of June)

Mayor Soldato summarized the Proclamation and requested residents to observe June as National Safety and Crash-Free Month with appropriate activities that promote driving safety and crash prevention. Paul Schoenback of Uni-Carrier accepted the Proclamation.

B. CLARKE ENVIRONMENTAL PRESENTATION

Mayor Soldato introduced Clark Wood, Vice President of Operations for Clarke Mosquito Control. Mr. Wood stated that Clarke was the City's contractor for over twenty-five years; he said their program goal was to prevent the annoyance of the mosquito and to prevent the West Nile Virus. He said that the West Nile Virus came to the United States in 1999 and rapidly moved from east to the west; all but Oregon and Washington have had the Virus. The Virus affects birds; the wet and hot season increases mosquitoes; and that prevention was increased. Mayor Soldato asked Mr. Wood to speak about the prevention process; Mr. Wood said that there were 52 sites where larvae were collected and tracked; that 15 acres within the City received treatment via helicopter; and that street catch basins were treated. Mr. Wood suggested that residents should keep their roof gutters clog free, keep bushes trimmed, eliminate stagnant water, and utilize good yard maintenance.
