10. **DEPARTMENT HEAD INFORMATION/QUESTIONS**

Alderman Avci inquired if the city's salt supply will be enough to get through the winter.

Director of Community Development/Municipal Services, Daniel Gombac, advised that the city has currently utilized 75% of the salt allotment. There is approximately 750 tons of salt remaining. Staff has begun mixing sand with the salt.

Alderman Poteraske inquired why the city is mixing sand with the salt.

Director Gombac responded that since the city has gone through so much salt during this very unusual winter, a conservative approach of mixing sand with salt is being taken. The mixture provides additional traction in colder temperatures, and reduces the amount of salt usage.

...advised that part of Walnut Avenue collapsed the end of December during a rainstorm. As a result the street has been closed. City staff is currently working with DuPage County in an attempt to obtain additional funding for the street repair, and the required permits. Staff will be requesting recommendation for approval of the required engineering study at the next Administrative Finance Committee Meeting. This study must be conducted prior to commencement of the project. This item will also be reviewed during the upcoming budget process.

Alderman McIvor inquired if the private property tree trimming is only available to residents in certain areas of Darien.

Director Gombac advised that the program is open to all residents and businesses of Darien.

Alderman Galan extended congratulations to Art Donner.

Alderman Gattuso announced that tickets to the Citizen of the Year Dinner/Dance will be available at City Hall February 1, 2009.

There being no further business to come before the City Council, it was moved by Alderman Poteraske and seconded by Alderman Marchese to adjourn.


