1. CALL TO ORDER

The regular meeting of the City Council of the City of Darien was called to order at 7:32 P.M. by Mayor Weaver.

9. CITY ADMINISTRATOR'S REPORT

Administrator Vana...

- ...announced that the city has a new telephone system. The main telephone number remains the same, but the individual extensions have changed.
- ...informed the residents of the remaining brush pick up schedule as follows: August 27 through 31, September 24 through 28, and October 22 through 26.
- ... Amnesty Day is September 17 through 21.
- ...city services and events are publicized on the city's website, cable television, and through the Direct Connect e-mail subscription.

- ...reminded the viewing audience that it is very simple to sign up for Direct Connect. This is an excellent means to receive notification of various city services, news, and events.

B. TREASURER'S MONTHLY REPORT – JULY, 2007

Treasurer Coren reviewed all year-to-date sources of revenue and expenditures and fund balances through the month of July 2007: General Fund Revenue \$3,618,120; General Fund Expenditures \$3,831,835; Current General Fund Balance \$3,275,709. Water Fund Revenue \$420,902; Water Fund Expenditures \$778,162 Current Water Fund Balance \$227,447. Motor Fuel Tax Fund Revenue \$171,102; Motor Fuel Tax Fund Expenditures \$33,656 Current Motor Fuel Tax Fund Balance \$399,313. Water Depreciation Fund Revenue \$45,751; Water Depreciation Fund Expenditures \$1,345,270 Current Water Depreciation Fund Balance \$2,181,432. Capital Improvement Fund Revenue \$2,470,564; Capital Improvement Fund Expenditures \$1,607,520; Current Capital Improvement Fund Balance \$905,264; Capital Projects Debt Service Fund Revenue \$2,666,614 with no expenditures and a fund balance of \$2,666,614.

Treasurer Coren reviewed the Cash Reserves Summary Report and updated the Council on the City's investments.

Alderman Galan...

...advised that a sales person came to his house last week, identifying himself as a representative from AT&T. This individual asked to see Alderman Galan's telephone records. It was later learned that the individual was representing Warren International, a company hired by AT&T. The script that the solicitors are provided by Warren International is designed to mislead the consumer into believing they are AT&T employees.

Administrator Vana...

...advised that residents who would like to avoid such visits can obtain "No Solicitors Invited" decals from City Hall. Solicitors are not allowed, by ordinance, where these decals are posted.

Alderman Avci...

...commented that he had a similar experience as Alderman Galan, and that he does have a "No Solicitors Invited" decal posted.

Darien resident, Elaine Kindt of 1325 Chapman addressed the City Council in opposition to the 1600 square-foot basketball court at Alderman Durkin's residence.

Attorney Murphey informed Ms. Kindt that she should follow the appeal process outlined in the Zoning Ordinance.
