ISSUE STATEMENT

Approval of a <u>resolution</u> awarding a contract to Homer Tree Care, Inc in an amount not to exceed \$135,765.00 for the City's 2017/18 Tree Trimming and Removal Program.

BACKGROUND/HISTORY

The proposed tree trimming program consists of trimming approximately 1,750 parkway trees, approximately 65 tree removals and stump grinding. Below are the subdivisions to be trimmed:

- Farmingdale Village
- Woodmere Townhomes
- Tara Hill Subdivision
- Carriage Way West

- Carriage Hill
- Glen Eagles
- Darien Woods
- Waterfall Glen

This year's program also includes contract pricing for the *Private Property Tree Trimming Program* to all the residents. The program would allow residents to have their private property trees trimmed or removed and stump grinding at the residents expense. The trimming will include removal of perished, diseased, interfering and weak branches, as well as removal of under branches as requested. The bid included unit prices for Private Property Tree Trimming that would be paid for directly by the residents. The bid price for the Private Property tree trimming is \$250.00 per tree in the front yard and \$375.00 per tree in the back yard. The contract also includes unit pricing for private property tree removal, and stump grinding.

The contract calls out for unit pricing for emergency services through November 30, 2018. Please find labeled as <u>Attachment A</u>, the bid results that were opened on July 17, 2017. The City received only one responsive bid. The second submittal indicated that he was unable to bid due to other commitments. Please note there are two optional contract extensions for 2018-19 and 2019-20 that may be exercised by the City. The contract extensions will be formally entertained at a future date, pending budget approval.

City of Darien (hereinafter referred to as the "CITY") and _____

(hereinafter referred to as the "CONTRACTOR").

WITNESSETH

In consideration of the promises and covenants made herein by the CITY and the

CONTRACTOR (hereinafter referred to collectively as the "PARTIES"), the PARTIES agree as follows:

SECTION 1: THE CONTRACT DOCUMENTS: This Contract shall include the

following documents (hereinafter referred to as the "CONTRACT DOCUMENTS") however this Contract takes precedence and controls over any contrary provision in any of the CONTRACT DOCUMENTS. The Contract, including the CONTRACT DOCUMENTS, expresses the entire agreement between the PARTIES and where it modifies, adds to or deletes provisions in other CONTRACT DOCUMENTS; the Contract's provisions shall prevail. Provisions in the CONTRACT DOCUMENTS unmodified by this Contract shall be in full force and effect in their unaltered condition.

The Invitation to Bid

The Instructions to the Bidders

This Contract

The Terms and Conditions

The Bid as it is responsive to the CITY'S bid requirements

All Certifications required by the City

Certificates of insurance

Performance and Payment Bonds as may be required by the CITY

SECTION 2: SCOPE OF THE WORK AND PAYMENT: The CONTRACTOR agrees to provide labor, equipment and materials necessary to provide the services as described in the CONTRACT DOCUMENTS and further described below:

Unit Pricing for Tree Trimming, Removals and Stump Grinding within the City of Darien and Tree Trimming, Removals and Stump Grinding for Private Properties

(Hereinafter referred to as the "WORK") and the CITY agrees to pay the CONTRACTOR

pursuant to the provisions of the Local Government Prompt Payment Act (50 ILCS 505/1 et seq.) the following amount for performance of the described unit prices.

SECTION 3: ASSIGNMENT: CONTRACTOR shall not assign the duties and obligations involved in the performance of the WORK which is the subject matter of this Contract without the written consent of the CITY.

SECTION 4: TERM OF THE CONTRACT: This Contract shall commence on the date of its execution. The WORK shall commence upon receipt of a Notice to Proceed and continue expeditiously for <u>30 days</u> from that date until final completion. This Contract shall terminate upon completion of the WORK, but may be terminated by either of the PARTIES for default upon failure to cure after ten (10) days prior written notice of said default from the aggrieved PARTY. The CITY, for its convenience, may terminate this Contract with thirty (30) days prior written notice.

SECTION 5: INDEMNIFICATION AND INSURANCE: The CONTRACTOR shall

indemnify and hold harmless the CITY, PARK DISTRICT, its officials, officers, directors, agents, employees and representatives and assigns, from lawsuits, actions, costs (including attorneys' fees), claims or liability of any character, incurred due to the alleged negligence of the CONTRACTOR, brought because of any injuries or damages received or sustained by any person, persons or property on account of any act or omission, neglect or misconduct of said CONTRACTOR, its officers, agents and/or employees arising out of, or in performance of any of the provisions of the CONTRACT DOCUMENTS, including any claims or amounts

recovered for any infringements of patent, trademark or copyright; or from any claims or amounts arising or recovered under the "Worker's Compensation Act" or any other law, ordinance, order or decree. In connection with any such claims, lawsuits, actions or liabilities, the CITY, its officials, officers, directors, agents, employees, representatives and their assigns shall have the right to defense counsel of their choice. The CONTRACTOR shall be solely liable for all costs of such defense and for all expenses, fees, judgments, settlements and all other costs arising out of such claims, lawsuits, actions or liabilities. The Contractor shall not make any settlement or compromise of a lawsuit or claim, or fail to pursue any available avenue of appeal of any adverse judgment, without the approval of the City and any other indemnified party. The City or any other indemnified party, in its or their sole discretion, shall have the option of being represented by its or their own counsel. If this option is exercised, then the Contractor shall promptly reimburse the City or other indemnified party, upon written demand, for any expenses, including but not limited to court costs, reasonable attorneys' and witnesses' fees and other expenses of litigation incurred by the City or other indemnified party in connection therewith. Execution of this Contract by the CITY is contingent upon receipt of Insurance Certificates provided by the CONTRACTOR in compliance with the CONTRACT DOCUMENTS.

SECTION 6: COMPLIANCE WITH LAWS: The bidder shall at all times observe and comply with all laws, ordinances and regulations of the federal, state, local and City governments, which may in any manner affect the preparation of bids or the performance of the Contract. Bidder hereby agrees that it will comply with all requirements of the Illinois Human Rights Act, 775 ILCS 5/1-101 et seq., including the provision dealing with sexual harassment and that if awarded the Contract will not engage in any prohibited form of discrimination in employment as defined in that Act and will require that its subcontractors agree to the same restrictions. The contractor shall maintain, and require that its subcontractors maintain, policies of equal employment opportunity which shall prohibit discrimination against any employee or applicant for employment on the basis of race, religion, color, sex, national origin, ancestry, citizenship status, age, marital status, physical or mental disability unrelated to the individual's ability to perform the essential functions of the job, association with a person with a disability, or unfavorable discharge from military service. Contractors and all subcontractors shall comply with all requirements of the Act and of the Rules of the Illinois Department of Human Rights

with regard to posting information on employees' rights under the Act. Contractors and all subcontractors shall place appropriate statements identifying their companies as equal

opportunity employers in all advertisements for workers to be employed in work to be performed. If awarded the Contract, contractor must comply with all provisions including, but not limited to, providing certified payroll records to the Municipal Services Department. Contractor and subcontractors shall be required to comply with all applicable federal laws, state laws and regulations regarding minimum wages, limit on payment to minors, minimum fair wage standards for minors, payment of wage due employees, and health and safety of employees. Contractor and subcontractor are required to pay employees all rightful salaries, medical benefits, pension and social security benefits pursuant to applicable labor agreements and federal and state statutes and to further require withholdings and deposits therefore. The CONTRACTOR shall obtain all necessary local and state licenses to the CITY prior to commencement of the WORK if applicable.

SECTION 7: NOTICE: Where notice is required by the CONTRACT DOCUMENTS it shall be considered received if it is delivered in person, sent by registered United States mail, return receipt requested, delivered by messenger or mail service with a signed receipt, sent by facsimile or e-mail with an acknowledgment of receipt, to the following: City of Darien

1702 Plainfield Road Darien, IL 60561 Attn: Director of Municipal Services **SECTION 8: STANDARD OF SERVICE:** Services shall be rendered to the highest professional standards to meet or exceed those standards met by others providing the same or similar services in the Chicagoland area. Sufficient competent personnel shall be provided who with supervision shall complete the services required within the time allowed for performance. The CONTRACTOR'S personnel shall, at all times present a neat appearance and shall be trained to handle all contact with City residents or City employees in a respectful manner. At the request of the City Administrator or a designee, the CONTRACTOR shall replace any incompetent, abusive or disorderly person in its employ.

SECTION 9: PAYMENTS TO OTHER PARTIES: The CONTRACTOR shall not obligate the CITY to make payments to third parties or make promises or representations to third parties on behalf of the CITY without prior written approval of the City Administrator or a designee.

SECTION 10: COMPLIANCE: CONTRACTOR shall comply with all of the requirements of the Contract Documents, including, but not limited to, all other applicable local, state and federal statutes, ordinances, codes, rules and regulations.

SECTION 11: LAW AND VENUE: The laws of the State of Illinois shall govern this Contract and venue for legal disputes shall be DuPage County, Illinois.

ISSUE STATEMENT

Approval of a <u>resolution</u> accepting the unit price proposal from Acres Group for the purchase and installation of the 50/50 Parkway Tree Program and the Parkway Tree Replacement Program in an amount not to exceed \$35,737.00

BACKGROUND/HISTORY

The 2017 Tree Planting Program calls out for the following:

- City and Resident 50/50 Parkway Tree Planting Program Staff has included \$4,000 (\$2,000 City funding and \$2,000 Resident funding) cost for residents that would like to participate in the 50/50 program.
- Storm, Ash Tree, and Project Related Replacement The program would allow for the planting of 2.5-inch caliper trees as part of the replacement of trees removed due to the Emerald Ash Borer.

Staff had advertised and sent out invitations to bid and received five (5) sealed bids on July 26, 2017, attached and labeled as <u>Attachment A</u>. Acres Group was the lowest bidder.

The program includes various selections of $2\frac{1}{2}$ - 4 inch caliper trees, planting, mulching and a oneyear guarantee. The program again includes a Private Property Tree Planting Program for residents at a pass through cost, see <u>Attachment B</u>. While the City is administering the Private Property Tree Planting Program, the property owner would be responsible for ordering and providing a payment directly to the awarded vendor.

The program is targeted to begin in late September, pending weather and will be advertised through the City's various media portals thus affording residents ample time to participate in the program. The Acres Group has performed very satisfactory tree services for the City in the past.

Staff recommends approval accepting the unit price proposal from Acres Group for the purchase and installation of the 50/50 Parkway Tree Program and the planting of various parkway trees in an amount not to exceed \$35,737.00

ISSUE STATEMENT

A <u>resolution</u> authorizing the emergency purchase of one new 2017 Hydraulic Hammer-WT Hammer Work Tool H65E attachment from Patten Cat in an amount not to exceed \$11,500.

BACKGROUND/HISTORY

The proposed hammer is an attachment for the recently purchased Skid Steer Bobcat. In 2016 a replacement jack hammer was purchased for the backhoe and is utilized for breaking out asphalt and concrete. Unfortunately the jack hammer use on the backhoe is causing stress and failure on the backhoe, particularly the Wain Wright coupling. The coupling allows the backhoe to maneuver in various angles and without the coupling many digs would be difficult due to utility conflicts. If the backhoe did not have the coupling, the jack hammer attachment would not be a concern. Both items are critical to the City's various excavation operations. See E mail summary labeled as <u>Attachment 1</u>.

The Staff has reviewed alternatives regarding a jack hammer and determined that a jack hammer on the Bobcat would be the optimal solution. Staff is requesting the purchase of one new jack hammer with fittings for the Bobcat and declaring the existing jack hammer as surplus. The existing hammer will be declared as surplus and a separate agenda memo will be presented at a later date for City Council approval. The purchase price of the jack hammer was \$23,780 and Patten is offering us a trade in value of approximately \$14,000.

The Staff has selected Patten Cat to supply the jackhammer attachment and is the awarded vendor for the National Intergovernmental Purchasing Alliance-National IPA City of Darien Participation Agency Member No. 228633, for equipment sales to municipalities nationally. Attached and labeled as <u>Attachment 2</u>, pages 1-2 is information regarding National IPA. Attached and labeled as <u>Attachment 3</u> is the cost breakdown and specifications for the 2017 Hydraulic Hammer.

Dan,

Here is the quote that we got for a hydraulic hammer for the skid steer. In talking with Pete from Patten our skid steer is supposed to be coming the first week or two in September. The cost to rent the exact same hammer from Patten would be \$1,900/month. We are currently paying \$1250/week or \$3,750/month for the backhoe with the hydraulic hammer (plus delivery and pickup \$350 max each way).

Pete from Patten was able to get Woods Equipment to cover the Wain Roy Cylinder because we are a good customer. We received the part last week and Tom had a company put it together with specialized tools for a few hundred dollars and it is back on the machine. Over the past 4 years or so we have had 4-5 Wain Roy cylinders break leaving us down a machine at various times. We initially thought that due to the old hammer and newer machines that we were having issues. Now with a new hammer and new machine we continue to have the same problem. We are afraid to continue to use the hydraulic hammer on the backhoes as we are afraid that we will continue to have trouble and break machines. Unfortunately, the problem seems to be that due to the nature of the Wain Roy Swinger Knuckle/Coupler system (allowing movement side to side and not a solid knuckle/coupler) it is the weakest point and that seems to have an adverse effect when used with the hydraulic hammer due to the violent nature of the hammer hitting and breaking apart the various surfaces. Even having the Wain Roy lockout kit (a valve that doesn't allow hydraulic fluid to go to the parts that control the coupler to move side to side) installed on the new backhoe hasn't made a difference.

Basically, I think we should buy a hydraulic hammer for the skid steer immediately so that we avoid future issues using the hammer on the backhoes. As a point of reference all of the concrete companies have their skid steers set up with a hydraulic hammer and don't have issues. Last year when we had issue with one, Rick from H&R said that they also use that setup for breaking asphalt & concrete. So it seems that this way is proven successful.

Pete from Patten is on vacation this week but told me verbally that Patten is willing to give us around \$14k for our hydraulic hammer. We could also try and sell it on Public Surplus and see what we get that way as well.

If we continue to use the hydraulic hammer on our backhoes and have trouble these are the two scenarios:

- Each time we break one → The part has to be ordered and is 10-14 days out for delivery. Figure a few days to get the quotes from companies and give purchase authorization and then figure a day or two to disassemble and reassemble. So all in all we are 2-3 weeks for rental of a machine while we fix the broken machine and lets just figure Tom puts it back together. All in all that rental & repair will cost us (\$5,150 \$6,400) for each occurrence.
 - Machine rental \rightarrow \$2,500 \$3,750
 - Deliver and pick up of machine \rightarrow \$700
 - o Part → \$1,700
 - Delivery of Part → \$250
- We can remove one of the existing Wain Roy Swinger Knuckle/Coupler's from one of our backhoes and retro fit it with a non-swinger Wain Roy Coupler → This would mean that we remove the weak link and everything needs to be retro fitted to accommodate the change. We will assume that Tom can do all of the work, but Patten/Cat may need to get involved as well. Total repair could be \$1,500 to \$5,000 but we lose the side to side movement functionality of our digging bucket. Meaning digging under and around utilities is now much more difficult with that one machine.
 - New knuckle/coupler for backhoe \$1,500 \$2,500 (I'm guessing)

- If Tom did this work it would probably take 2-3 days and Patten/Cat may have to get involved due to the hydraulic lines so we would incur whatever that would cost (\$1,000/day)
- Not sure what the lead time for that would be but we would have to keep renting a machine for that time frame as well so at least the additional \$1,250/week while we do the work plus delivery and pickup of rental machine (\$700).

I think Patten offers financing on the work tools, I don't know what the terms for that are, but we could explore that to get us through until next budget year to make the full final payments on it as well if that makes it any easier.



ISSUE STATEMENT

Consideration of motion to approve a request to allow a *connection fee payment plan* for the unincorporated property at 806 Plainfield Road.

OVERVIEW/DISCUSSION

Attached is a request from the property owners (Charles and Vertis Wiley) at 806 Plainfield Road. The Wileys recently purchased the home and wish to convert from well water to Lake Michigan water. The property is located in the Bruce Lake Subdivision which is an unincorporated neighborhood. The City provides water to this neighborhood as part of an intergovernmental agreement between Darien and DuPage County. However, this particular property is not included in the intergovernmental agreement due to its location on Plainfield Road. The City does have a water main that runs along Plainfield Road and fronts 806 Plainfield Road. Since this property was not covered by the intergovernmental agreement the section of the City Code below covers a special connection fee. The connection fee was established to repay the City for the original cost of the water main and is required to be paid in full prior to connection to Darien's water system. Based on the ordinance, the owner's connection fee is estimated at \$15,345. The owners are requesting to pay the fee over a period of time as requested in their attached letter.

CITY CODE-6C-4-6: FEES

4. Additional Connection Charges; Acquisition Areas: Notwithstanding the provisions of any other ordinance, all potential water users who live within the area described below, and who have City water available at the property line, **shall pay the following connection charge prior to connection to the City water system:**

(a) For all properties located in the area bordered generally by 75th Street on the north, Lemont Road on the west, Darien City limits on the south, and Fairview Avenue on the east, the owners thereof shall pay a connection charge of twenty nine dollars (\$29.00) per front foot.

(b) For all properties located in the area bordered generally by Lemont Road on the west, Kearney Road (if extended south to I-55)on the east, Interstate 55 on the south, and the Darien city limits on the north, the owners thereof shall pay a connection charge of thirty three dollars (\$33.00) per front foot.

(c) For all properties located in the area within the city extending west of Lemont Road to the Darien city limits between 83rd Street on the north and the Darien city limits on the south, and known generally as the Farmingdale village area, the owners thereof shall pay a connection charge of thirty five dollars (\$35.00) per front foot.

(d) For all properties being served by the former Lake-In-The-Woods System, the owners thereof shall pay a connection charge of thirty three dollars (\$33.00) per front foot. This connection charge shall not apply to properties subject to recapture payments to the county of DuPage with respect to the county's extension of a certain water main along Plainfield Road. (Ord. 0-62-92, 12-7-1992)

If the committee recommends approval of the request, staff will work with the City Attorney to prepare a formal agreement assuring the City receives the full connection charge.

We are Charles and Vertis Wiley. We are taking this opportunity to write you in an effort seeking your consideration in obtaining monthly installments for this 'recapture fee'.

We are hard working, friendly, trustworthy, God-fearing Christians. I married my wife Vertis on June 16, 2016 and we closed on our first home together on June 8, 2017 – what a happy day! My first home – what a happy day! We were aware we needed to hire a special licensed plumber to obtain domestic water into our home and that we would need a couple of permits to coincide with this.... and we saved \$10,000, hoping this would accomplish this task. What we did not know and it was not revealed to us (to our understanding not unlawful, but possibly borderline unethical), was that there was a mandatory \$15,345 recapture fee that needed to be paid simultaneously. It is with heartfelt sorrow that I acknowledge that as of this writing, we do not have running water in our new home (can't shower, cook, clean, nor go to the restroom). This is disheartening because we were not informed, thus, we did not prepare for such an expense / hardship.

- 1. A permit from the City and the County of DuPage (\$ unknown)
- 2. Fees related to the water service (If this is the TAP Fee (\$1,905)
- 3. Fees related to the recapture (\$15,345)
- 4. DuPage County-Permit to work within the right of way will be required (\$ unknown)
- 5. Property owner responsible for securing a licensed plumbing contractor to install:
- the water service
- water meter (\$12,500-16,000) (3 different estimates)

We are proposing the following two options for your consideration, with the notion that if we are blessed with additional finance means, we will make extra payments, thus paying this off ahead of schedule;

1. Down payment of \$3,000 and monthly installments for three years - with no early payoff penalty;

2. Down payment of \$4,000 and monthly installments for two years – with no early payoff penalty;

Mayor Weaver, we need your help in securing an exception / special consideration for this \$15,345 recepture fee.

We look forward to blending into this beautiful community as responsible citizens and caring neighbors. Again, thank you so much for your consideration.

MINUTES CITY OF DARIEN MUNICIPAL SERVICES COMMITTEE June 26, 2017

PRESENT: Alderman Joseph Marchese – Chairman, Alderman Thomas Chlystek, Dan Gombac – Director, Steven Manning - City Planner, Alderman Tina Beilke

ABSENT: Alderman Thomas Belczek

ESTABLISH QUORUM

Chairman Joseph Marchese called the meeting to order at 6:41 p.m. at City Hall Council Chambers, Darien, Illinois and declared a quorum present.

NEW BUSINESS

a. <u>PZC 2017 - 02: 7620 Wilton Court:</u> Petitioner seeks approval of a variation to allow boat storage on their existing driveway in their front yard.

Mr. Steve Manning, City Planner reported that in 2010 the property owners submitted a petition for a new single driveway in the rear yard off Manning Road that would provide access to a new garage for boat storage in their rear year. He reported that the City Council denied the request based on the proposed driveway creating a safety hazard on Manning Road.

Mr. Manning reported that the 2017 petition included a plan for a new circular driveway in the rear would provide access to a new boat storage pad in their rear yard. He reported that at the May 3rd PZC meeting, the petitioners asked for a continuation to modify their proposal and on May 30th they sent a letter explaining their preference to store their boat on their existing driveway.

Mr. Manning reported that at the June 7th PZC meeting the petitioners stated that all of the neighbors were in favor of the boat being stored in the front yard and the PZC voted recommending approval based on three conditions: 1. The variation should be for one boat only, 2. The variation should expire when the petitioners no longer store their boat on the property and 3. The variation should expire when the petitioners sell the property.

The petitioners, Diane and Ted Schimel stated that they were proud of Alderman Sylvia McIvor who went above and beyond to help the PZC understand.

Chairperson Marchese stated that he was fully expecting a MSC meeting with a petition for a circular driveway. He questioned why it was withdrawn.

Ms. Diane Schimel stated that they did not know that the neighbors preferred to see the boat stored on the driveway and that she was not aware that it was an option.

Chairperson Marchese stated that the property on the east would need to be elevated. He questioned if a pad on the west was an option.

Mr. Dan Gombac, Director reported that it was staff's opinion that the grade would need modifications.

Mr. Manning stated that the west is relatively flat and there would be a driveway crossing in the front.

Chairperson Marchese stated that he has served on the City Council for a number of years and that there were hours spent writing the ordinance for recreational vehicles to deliver a policy. He stated that allowing a variation opens up Pandora's Box with regard to the City and that if approved the City will be deluged by people with boats, trailers, snow mobiles, etc. He further stated that he does not see how this can be approved.

Ms. Schimel stated that the City recently approved a similar petition.

Chairperson Marchese stated that the petitioner Ms. Schimel referenced had his boat in the side yard.

Ms. Schimel recited a list from her attorney stating why the petition should be approved.

Chairperson Marchese suggested that the homeowner look at putting the boat in storage. He stated that Mayor Weaver was very much against allowing this or changing the Code.

Mr. Gombac reported that there was a photo in the packet showing the left (south side). He stated that staff looked at if there was potential of a grade drop off and a retaining wall. He further stated that staff asked the City Engineer to review and he reported that the drainage and utility easements could be forgiven and that they would need to grant a variation for the side yard.

Ms. Schimel stated that the City told them where to store the boat.

Mr. Gombac stated that the City did not tell the Schimel's where to put the boat and that the issue was the second driveway cut. He stated that staff discussed the drainage easement and that the petitioners thought it was too costly.

Ms. Schimel stated that they are getting misdirected and that the PZC unanimously approved the request.

Chairperson Marchese stated that the City Council does not always vote for what the PZC recommends. He stated that he was surprised they approved it and suggested that the petitioners look at the side property.

Alderman Chlystek stated that he visited the property five minutes before the meeting and that there is a blind spot to turn right and he is concerned.

Mr. Gombac stated that they could explore the driveway off Manning but there will be costs to explore and possibly a culvert and/or a retaining wall would be needed. He stated that costs may range from \$15,000 - \$20,000 but it can be done.

The petitioners stated that they have not had any estimates.

Chairperson Marchese questioned if they could store the boat.

Ms. Schimel stated that they cannot financially afford it.

Mr. Gombac reported that this would have to go back to the PZC for approval. He recommended getting costs and look at the side.

b. <u>2225 Shannon Court:</u> Petitioners seek approval of a Plat of Vacation of Oldfield Road right-of-way to add to their home site.

Mr. Steve Manning, City Planner reported that there is a new homeowner Todd Wrenn. He stated that there is a portion of his yard which is an odd shaped triangular area between the lot and sidewalk which belongs to the City. He reported that the previous owner had landscaped the triangular area and maintained it as part of his backyard and that the new owners would like to own the triangular area with the understanding that they would be paying taxes on it.

Mr. Dan Gombac, Director reported that Public Works will not be affected and that the quadrant is useless to the City.

The petitioner, Mr. Todd Wrenn stated that he would like to put in a fence to visually make it look better. He stated that he just wanted to make it a formality and is willing to grant an easement if the City needs to get in.

There was no one in the audience wishing to present public comment.

Alderman Marchese made a motion and it was seconded by Alderman Chlystek approval of a Plat of Vacation of Oldfield Road right-of-way to add to their home site.

Upon voice vote, THE MOTION CARRIED UNANIMOUSLY 2-0.

Chairperson Marchese stated that the public hearing will be held on July 17th before the City Council meeting.

c. <u>2109 Cottage Lane</u>: Petitioners seek approval of a re-subdivision plat of Lot 20 in Rolling Knolls to adjust the width of side yard easements and building setbacks.

Mr. Steve Manning, City Planner reported that this is the smallest lot for Rolling Knolls- Lot 20. He reported that the developer would like to shift the home 4.34' south to avoid conflict with the ComEd line. He further reported that the shift would put lot 19 and 20 closer together and that a revised plat will have to be approve but a public hearing is not needed.

The petitioner, Mr. Paul McNaughton stated that there is 9 1/2 ft. easement and that he is flipping the set back. He stated that the total side yard setback will not change.

Mr. Gombac stated that staff has suggested that ComEd move the cable.

There was no one in the audience wishing to present public comment.

Alderman Marchese made a motion and it was seconded by Alderman Chlystek approval of a re-subdivision plat of Lot 20 in Rolling Knolls to adjust the width of side yard easements and building setbacks.

Upon voice vote, THE MOTION CARRIED UNANIMOUSLY 2-0.

d. <u>Resolution</u> - Approval of a resolution authorizing the purchase of one new 2017 Ford F 250XL 4X4 Super Cab from Currie Motors in the amount of \$41,719.

Mr. Dan Gombac, Director reported that the proposed vehicle replaces a 2009 Chevrolet Silverado with 125,000 miles. He reported that the purchase will be through the Suburban Purchasing Cooperative Program.

There was no one in the audience wishing to present public comment.

Alderman Marchese made a motion and it was seconded by Alderman Chlystek approval of a resolution authorizing the purchase of one new 2017 Ford F250XL 4X4 Super Cab from Currie Motors in the amount of \$41,719.

Upon voice vote, THE MOTION CARRIED UNANIMOUSLY 2-0.

e. <u>Resolution</u> - Approval of a resolution authorizing the mayor to accept a proposal from Christopher B. Burke Engineering, Ltd. In an amount not to exceed \$29,204 for Conceptual Design Services for the Cass Avenue and I-55 Cloverleaf Interchange.

Mr. Dan Gombac, Director reported that this is for conceptual drawings for the beautification project for the I-55 and Cass Avenue corridor. He reported that IDOT will need to approve but they are not participating.

f. <u>Resolution</u> - Approval of a resolution to enter into a contract with Amber Mechanical Contractors for the removal and replacement of the Heating, Ventilation and Air Conditioning (HVAC) system at the Darien Police Department, 1710 Plainfield Road, in amount not to exceed \$453,731 and A contingency in the amount of \$15,000 for unforeseen repairs related to the removal and replacement of HVAC components.

Mr. Dan Gombac, Director reported that the HVAC system at the Police Department has exceeded its life expectancy. He reported that they system is 25 years old. He reported that this is in the budget.
