Alderman Biehl inquired what the County Board action was on August 14th in regard to the bond issue. Administrator Curneal responded that he did not know the result, but would inquire.

Mary Toniolo, 8492 Sandalwood Court, raised questions about the Crossroads of Darien project. She noted various problems within and surrounding the development. Mayor Soldato asked Ms. Toniolo to contact Director Charlton in regard to the issues that the homeowners have about the project.

Mr. Tom Sailer, 7957 Hedgwood Drive, stated that he was President of the Board of Directors for the Woodmere Townhome Association. On behalf of the Board and homeowners, he thanked the Mayor and City Council for expediting the completion of the street.

Mr. Dan Nowaczyk, 1101 Timber Lane, asked Chief Musial how many calls were received regarding Jewel since April. Chief Musial approximated the number of calls. Mr. Nowaczyk stated that he calls the Police Department on a regular basis in regard to the on-going noise problems. He asked that the issues be re-addressed by Committee. Mayor Soldato stated that delivery issues were addressed and those have been enforced. The Mayor verified that there were new facts to address; Mr. Nowaczyk agreed. Alderman Weaver stated for the record that this was the first time that Mr. Nowaczyk reported that Jewel continued to load and unload trucks throughout the night; she indicated that Mr. Nowaczyk contacts her between 5:00-6:00 A.M. regularly. Mayor Soldato suggested conversing with Jewel's new manager; Mr. Nowaczyk stated that the manager instructed him to contact the Darien Police Department, not the Jewel.
