#### **Item 4a – Ordinance Authorizing Sale of Surplus Property – Police Department**

Staff requests Committee and Council approval for the sale of surplus property consisting of unclaimed found property, worn out equipment and motor vehicles. A detailed list is outlined in the agenda memo.

## **Item 5a – Cleaning Contract**

Staff requested to not opt out of the cleaning contract with Best Quality Cleaning for FYE 2010. They were the low bid by a significant amount.

#### **Item 5c – Ammunition Purchase – Police Department**

Staff requests Committee and Council approval for an expenditure of budgeted funds in the amount of \$6,304.32 from police line item 40-4217, for the purchase of ammunition. Due to fluctuations in the ammunition market, several orders came at the same time, which increased the expenditure over the \$5,000 spending limit.
