7. MAYOR'S REPORT

Mayor Weaver...

...read into the record a Proclamation declaring June 4, 2007 as Eisenhower Junior High Music Department Day in the City of Darien. Mayor Weaver presented the Proclamation to the Choir Director, Carrie Vaccaro and the Director of Bands, Maria Zurbano. Mayor Weaver presented a Darien City pin to each of the students in attendance. A picture that will appear on the City's "Hall of Fame" was taken.

8. CITY CLERK'S REPORT

Clerk Coleman...

... invited the Council Members, audience, and residents to attend a Coffee with Mayor Weaver, which is scheduled to take place on Saturday, June 16th from 9:00 A.M. to 10:00 A.M. at Carmelite Carefree Village, 8419 Bailey Road.

... announced that the Planning & Zoning Committee Meeting of June 6, 2007 has been cancelled.

... thanked the VFW 2838 for the heartfelt Memorial Day observance that was held at Darien Community Park. She noted the Eisenhower Junior High Band also participated in this event.

9. CITY ADMINISTRATOR'S REPORT

Administrator Vana...

... has received a few calls questioning the color of the water tower. The color selected for the water tower is tan, and will be completed in a very nice manner.

10. DEPARTMENT HEAD REPORT

Police Department Chief Robert Pavelchik...

... expressed gratitude to the residents who attended the City's open house.

...in response to a concern expressed by Alderman Marchese at a previous meeting, advised that his concerns on Hemlock have been addressed.

...advised that there has been a parking problem at the ball field. Chief Pavelchik requested that those attending games at the ball field be respectful of the parking restrictions. Parking regulations will be enforced.

...stated the three offenders in an armed robbery, which took place at the Shell Station on July 12, 2006, were apprehended, have pled guilty, and have been sentenced. The two adult offenders have been sentenced to 8 and 12 years at the State Penitentiary, and the one juvenile has been sentenced to 8 years in the Juvenile detention facility. He commended the police department for their outstanding efforts.

12. STANDING COMMITTEE REPORTS

Planning/Development Committee — Chairman McIvor announced that the next scheduled meeting is scheduled to take place on Monday, June 25, 2007 at 6:30 P.M. in the Council Chambers.

Public Works Water/Streets Committee — Chairman Marchese announced that the next meeting has been rescheduled to take place on to Monday, June 18, 2007 at 6:30 P.M. in the Council Chambers.

Administrative/Finance Committee — Chairman Poteraske announced that the next meeting has been rescheduled from June 11, 2007 to Tuesday, June 12, 2007 at 6:30 P.M. in the City Offices on the main floor.

13. QUESTIONS AND COMMENTS — AGENDA RELATED

Stan Mlyadrczyk of 1106- 69th Street suggested the City refund the DuPage Water Commission water rebate to the residents as Naperville is doing.

Mayor Weaver advised that a reduction of the water rates is on this evening's agenda for action. The city has received \$1.1 million from the DuPage Water Commission. These funds will be placed in the General Capital Improvement Fund while the Council Members look to future years when considering how the \$1.1 million rebate is to be used.

Administrator Vana explained why the rebate was issued, noting that the rebate took place after the city's budget was completed. Darien is passing on the savings through a rate reduction to the residents through action to be taken this evening. Most communities are using the rebate for capital projects. Administrator Vana believes that Naperville is providing a rate reduction to their residents; not a rebate. The City Council is looking at a two-year forecast for infrastructure and capital improvement projects. The use of the rebate will be reviewed in February during the budget review process.

Mr. Mlyadrczyk feels the funds should be used for water projects.

Mayor Weaver advised that the Water Commission issued the rebates with no restriction on how the funds are utilized. The City Council is forecasting necessary projects into the year 2010. The rebate could fund improvement projects with no tax increase to the residents.

Mr. Mlyadrczyk feels the residents should have input as to how the rebate is used.

Alderman Marchese advised that citizens are welcome to attend and participate in the budget review meetings that will be held in February 2008.

Mayor Weaver advised that a unique situation exists in that not all resident's water rates are the same. For example, residents of the Farmingdale area have been paying a higher rate since their water system had to be purchased. Their rates will be reduced even more than the \$.20 reduction since the debt service has been paid. Since this will affect the water fund, the City Council is taking a "wait and see" approach as to how the rebate will be used.

In response to Alderman McIvor, Administrator Vana advised that a reduction in the water rates from \$3.83 to \$3.63 is on this evening's agenda for action. The water users who have paid a higher rate represent approximately 16% of the water users.

Alderman Gattuso advised that Ward 4 residents would not see the rate reduction until they are on Lake Michigan Water. It is anticipated that it will take approximately six months to one year for that to occur.
