1. CALL TO ORDER

The regular meeting of the City Council of the City of Darien was called to order at 7:30 P.M. by Mayor Carmen D. Soldato.

6. RECEIVING OF COMMUNICATIONS

Alderman Cotton attended a residential meeting at the Darien-Woodridge Fire Protection District on January 14th regarding the development of their property. He noted that residents approached him and complimented Public Works for their recent snow plowing efforts.

7. MAYORÍS REPORT

A. 2003 CITIZEN OF THE YEAR NOMINATION

Mayor Soldato turned the meeting over to Alderman Weaver, who presented the Committee's nomination for the 2003 Citizen of the Year. She commented that the Committee received more letters this year than all other years. Alderman Weaver read the Citizen of the Year Committee nomination letter that acknowledged Father Gavin Quinn as their choice for the 2003 Citizen of the Year. The letter stated that "...His 'job'entails helping people"he has extended himself beyond the confines of his actual responsibilities"Father Gavin is known for reaching out to any person or family in need regardless of their church affiliation or chosen beliefs. He has been known to visit everyone and anyone who needs a listening ear, spiritual or practical advise and even offered to mediate a difficult situation"Hundreds of families have had food put on their tables, utility bills paid, transportation and clothing needs met"It is his own giving spirit and desire to serve people that make him unique and special"He is an extraordinary man who knows how to identify people in need and find a way of ministering to them"He has a gift for working with our children, especially teenagers. He has a soft spot in his heart for single parents, widowed, divorced and otherwise. He is incredible in his work with the sick and dying"He is invaluable in assisting anyone who has lost a friend or family member in deathÖFather Gavin personified the meaning of good citizenship"

8. CITY CLERK'S REPORT

Clerk Coleman:

—announced that the last day to file nominating petitions for the positions of Mayor, City Clerk, City Treasurer and Ward 3 Alderman was Tuesday, January 21st at 5:00 P.M.

—stated that there were three simultaneous filings at 8:30 A.M. on January 13th for Mayor: Carmen D. Soldato, Richard A. Biehl, and David V. Hagen; a lottery for ballot position is scheduled for January 29, 2003 at 4:30 P.M. in the City Council Chambers. Also, Joanne F. Coleman filed for City Clerk on January 13th; Kevin P. Monaghan filed for City Treasurer on January 16th and two people filed for Ward 3 Alderman: John F. Poteraske on January 13th and Suzanne Polkow on January 17th.

—noted that the last day to register to vote in the April 1st Consolidation Election was March 4, 2003. She stated that applications for Absentee Ballots were available at City Hall or the registered voter could call the DuPage County Board of Election at (630) 682-7440.

CITY ADMINISTRATORÍS REPORT

Administrator Vana reminded residents to complete and return the Citizen Survey to the City; the survey was included in the Darien Data. He commented that they would be very helpful with preparation of the budget.

10. DEPARTMENT HEAD REPORT

Asst. Director of Public Works Robert Mengarelli:

-commented that the draft Public Works budget had been completed and submitted.

-mentioned that Well 2 was in the process of repair.

-noted that the Water Tower at Plant 5 was also being repaired; he said that when the work was completed, it would be refilled and placed back into service.

—spoke about the 2003 Street Rehab Program; he said that three miles of roadway would be repaired plus Ridge Road would be widened and connected.

-reviewed the procedures for snow-plowing. He said that if there was less than an inch of snow, streets were salted; if there was more than one inch, it was a full operation of plowing and salting.

—said that the Tree Trimming Program bid was on the agenda; this was the ninth year of trimming parkway trees. He noted that a five-year trimming program had been implemented and this was the third year of that program; the cycle would be repeated.

Alderman Hagen complimented Public Works for their snow plowing efforts. He inquired about the brush/plow utilized on the sidewalks; Asst. Director Mengarelli explained when the brush or plow was used.

E. CONSIDERATION OF A MOTION TO APPROVE A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE BOARD OF EDUCATION OF HINSDALE TOWNSHIP HIGH SCHOOL DISTRICT 86 AND THE CITY OF DARIEN

It was moved by Alderman Biehl and seconded by Alderman Marchese to approve

RESOLUTION NO. R-01-03 A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE BOARD OF EDUCATION OF HINSDALE TOWNSHIP HIGH SCHOOL DISTRICT 86 AND THE CITY OF DARIEN as presented.

Alderman Biehl commented he had no problem with the signage. He stated that District 86 was now willing to work with the City for their sign but would not work with the City or County to help resolve the flooding problems in Marion Hills, which involved the eastern end of their property.

Mayor Soldato commented that a swift response had not been received from the District in regard to the flooding problem; he said that the City must move forward. He noted that they attempted to cooperate by coming to the City for approval of this sign even though State law does not require them to do so. Mayor Soldato reminded the City Council that they stated at a recent meeting that the City needed to cooperate with other taxing bodies.

Alderman Hagen reminded Council that they had previously voted that the Zoning Ordinance pertained to all; he mentioned the addition at Eisenhower Junior High School and the parking lot at Lace School. He felt that all should be treated equally and that special treatment should not be given to the District, particularly in regard to the public hearing requirement and fees related thereto.

Attorney Murphey stated that the School District was subject to the Cityís zoning regulations but the buildings were exempt from building code and related construction requirements. Attorney Murphey

considered this sign to be within a gray area and that the Sign Ordinance had exemptions for various governmental signs.

Mayor Soldato stated that the School District did not have to bring forth the plans for the signage because it was exempt under State law. He noted that Administrator Vana communicated with the District; an Intergovernmental Agreement was compromised between the entities.

Alderman Hagen noted that the variations for the sign included area coverage and the electronic signage.

17. QUESTIONS, COMMENTS AND ANNOUNCEMENTS Ó GENERAL

Alderman Hagen noted that the Darien Historical Society would host iSunday Dinnerî on February 2nd at Ripples from 1:00-4:00 P.M.; the cost per person was \$22.50.

Gary Kersting, 1044 Central ñ Brookeridge, commented that he attended numerous meetings over the last ten years in regard to the development of the property at 83rd & Main Street. He said that residents were concerned about lighting, drainage, traffic and wetland issues. He said that his family was impacted by the lights from the existing Osco, 83rd & Lemont, which reflect into his bedroom at 2:00 A.M. He said that the City developed property for its benefit and negatively impacted other residents. He asked for information to whom they could direct concerns and problems.

Mayor Soldato stated that Mr. Kersting could contact him directly or Administrator Vana. He said that the City was cognizant of their concerns and he felt that they had been incorporated into the plan. He noted that this was the first time that anyone came forward to say that there was a problem with the Osco lighting; he said that staff would contact management.

Marlene Richardson, 9 S 480 Main Street, spoke in opposition of the project; she said that they submitted a petition that contained 294 resident signatures against the project. She inquired about traffic, parking, handicapped parking, and landscaping. She requested a "NO RIGHT TURN" into Brookeridge for privacy.

Michael Pizzuto, representative of the DuPage Housing Authority, thanked Council for their foresight with the proposed affordable senior housing project. He said that when the units became available that Darien residents would have first preference, moms and dads of Darien residents would have second preference, and former Darien residents would have third preference, which was critical after the development was operational and had a long waiting list.

18. ADJOURNMENT

There being no further business to come before the City Council, it was moved by Alderman Marchese and seconded by Alderman Poteraske to adjourn.
