City Clerk Coleman...

9. CITY ADMINISTRATOR'S REPORT

Administrator Vana noted that included in Friday's Administrator's Report was information on the Federal Stimulus Plan. Director Gombac and Administrator Vana participated in a conference call last week with Judy Biggert and a number of individuals from the State and other organizations regarding distribution of transportation funds included in the federal stimulus bill. Although the City of Darien has submitted a list of projects to the State and Federal Government, the city's residential street programs do not meet the requirements for funding through the stimulus program. Stimulus funds are geared toward major arterial roads. There is, however, a component of the stimulus program which has to do with public safety. The city will be researching this avenue to see if there are any funds available. Confirmation of funding from DuPage County in the amount of \$75,000 has been received. An intergovernmental agreement between DuPage County and the City of Darien will be required to receive those funds.

10. DEPARTMENT HEAD INFORMATION/QUESTIONS

Alderman Galan asked Director Gombac to apprise the Council Members of what is going on at 67th & Leonard.

Director Gombac advised that a week and a half ago, the road at 67th and Leonard began to collapse. Repair of Leonard Drive will take place in conjunction with the ditching project which will presented to the City Council for approval within the next couple of weeks. The road is currently barricaded, and will remain so until the ditching project begins. Staff will closely monitor the situation.

Administrator Vana advised that the ditch and roadway repairs are included in the new year's budget.

B. TREASURER'S MONTHLY REPORT - FEBRUARY, 2009

Treasurer Coren reviewed all year-to-date sources of revenue and expenditures and fund balances through the month of February, 2009: General Fund Revenue \$10,003,963; General Fund Expenditures \$10,420,884; Current General Fund Balance \$3,046,361; Water Fund Revenue \$2,834,518 Water Fund Expenditures \$2,740,444; Current Water Fund Balance \$692,809; Motor Fuel Tax Fund Revenue \$533,972; Motor Fuel Tax Fund Expenditures \$555,236; Current Motor Fuel Tax Fund Balance \$51,790; Water Depreciation Fund Revenue \$173,520; Water Depreciation Fund Expenditures \$742,048; Current Water Depreciation Fund Balance \$662,374; Capital Improvement Fund Revenue \$2,936,657; Capital Improvement Fund Expenditures \$1,355,715; Current Capital Improvement Fund Balance \$2,680,016; Capital Projects Debt Service Fund Revenue \$23,171; Capital Projects Debt Service Fund Expenditures \$1,237,941; and a current fund balance of \$236,473.

Alderman Avci inquired why the salary balance under the Public Works Streets Fund is negative this month.

Treasurer Coren explained that there was a reclassification, allocating half of Dan Salvato's and 40% of Ashley Preuter's salaries for the year to the Water Depreciation Fund, causing that year-to-date, catch up adjustment.

16. NEW BUSINESS

There was no new business to come before the City Council.

17. QUESTIONS, COMMENTS AND ANNOUNCEMENTS — GENERAL

Alderman Marchese announced that the Darien Lions Club Annual Pancake Breakfast will be held at Eisenhower Junior High on Sunday, March 22, 2009.

In regards to Chief Pavelchik's statistical report, and in the interest of clarifying how the Police Department is run and staffed, Alderman Galan requested calls for service be defined as to which incidents are handled by uniformed officers and which are handled by the Community Service Officer.

Chief Pavelchik responded that it would be important to include the time frame of each incident. The Community Service Officer is on duty Monday through Friday between 7:00 A.M. and 3:30 P.M. The CSO handles incidents such as vehicle lock outs and animal complaints. After hours and on weekends, all incidents are handled by uniformed officers.

Mayor Weaver suggested that the Police Chief and Administrator determine the format for this report which will then be reviewed during a City Council Work Session.

Alderman Galan advised that during the budget review sessions, the City Council spent a considerable amount of time discussing the contract which is in place between the city, schools, and the Darien Historical Society. During a conversation with Chip Johnson, Alderman Galan inquired why the school does not rent directly to the Historical Society. Alderman Galan was told that, at the time the contract was created, the city wanted to be involved. Alderman Galan reported that Chip Johnson would have no objection to the city's withdrawal from the contract. Alderman Galan requested the contract be sent to a committee for review and discussion.

Mayor Weaver agreed that now would be the time to extract the city from this contract.

In regards to Chief Pavelchik's report, Alderman Avci feels that the usefulness of this report will become more apparent with time. Alderman Avci stated that it is important to maintain the historical data.

Alderman McIvor commented that a yearly comparison report of the crime statistics would be of interest to the residents.

Mayor Weaver noted that an annual statistical report is published in the newspaper.

Chief Pavelchik advised that due to the Police Department's new reporting system, incidents which were not included in the past are now in the report, causing the theft line item to significantly rise. Chief Pavelchik explained that in the past, juveniles in custody for retail theft, who had no previous record, were issued ordinance tickets which are not included in the crime statistics. With the new reporting system, all thefts are included in case reports and count as a crime statistic. The council members will receive a letter of explanation of the dramatic increase in the theft category from the Chief. The Chief advised that next year's comparison will be fairer since the reporting will be the same.

Arleta Peknik brought up the shooting incident which occurred at an apartment building on Cass and 67th Street in Westmont. Ms. Peknik inquired if Darien was addressing this incident, and if it will be a problem in the future.

Chief Pavelchik advised that the shooting occurred approximately two weeks ago. Chief Pavelchik advised that the Darien Police Department is a mutual aid responder to the Westmont Police Department. The Darien Police Department assisted Westmont Police on that day.

There being no further business to come before the City Council, it was moved by Alderman Durkin and seconded by Alderman Poteraske to adjourn.
