Alderman McIvor received calls regarding burning of materials outdoors.

Mayor Weaver entered into the record a letter from Dan and Bridget Wyncott of 7122 Walden Lane complimenting Daniel Gombac and all involved with the Exner Road/Walden Lane Drainage Project which solved their drainage issues.

In response to Alderman Poteraske, Administrator Vana advised that surveys are sent to residents in affected areas following most Municipal Services projects. Once a majority of the current survey responses have been received, they will be brought to the City Council for review.
