

## **Executive Summary**

The Greater Chicagoland Economic Partnership (GCEP) is a regional strategic economic development alliance formed through extensive discussions with cross-sector stakeholders over the course of three years (2020-2023). Spearheaded by the Brookings Institute and the Chicago Metropolitan Agency for Planning, with support from the Searles Fund at the Chicago Community Trust, GCEP aims to drive inclusive economic growth in the Chicagoland region.

#### **GCEP** Overview

In its first year, GCEP efforts successfully created or retained over 8,500 direct and indirect jobs in the region, which generated over \$715 million in earnings for workers. The partnership focuses on promoting the region's assets, including transportation infrastructure, diverse talent, key industries, and the innovation ecosystem, including universities, incubators, and startups. Partners include Cook, DuPage, Kane, Kendall, Lake, McHenry, and Will counties, along with the City of Chicago and World Business Chicago.

#### Chicagoland's Economic Landscape

The WBC Research Center led the development of a regional economic asset map and accompanying report, "Chicagoland's Economic Landscape." These tools identified the region's strengths and inputs for economic growth and prosperity, across categories like human capital, innovation, and infrastructure.

#### **Regional Business Development**

GCEP's focus on "Pro-Chicagoland Decisions" led to 64 successful decisions, 40 regional leads shared, and 24 connections made to county partners in its first year. This resulted in 8,576 jobs that were created or retained and over \$715.9 million in direct or indirect worker earnings. GCEP played a crucial role in significant business decisions, such as S&C Electric's expansion, Upside Foods' entry, SyBridge Technologies' consolidation, Flender Corporation's expansion, Ravago's Midwest distribution center, Henry Broch Foods' headquarters expansion, General Kinematics' presence in Crystal Lake, and Lion Electric's Joliet factory.

In conclusion, GCEP's first year demonstrated successful collaboration and impactful economic development, setting the stage for sustained growth and regional prosperity in the Chicagoland area. The following report more thoroughly describes the collaboration and impact.

## **Overview of GCEP & Membership**

#### **Engaging the Community**

Over the course of three years (2020 - 2023) of discussions with 75+ cross-sector stakeholders, through interviews and roundtables, intent was assessed for regional collaboration and past efforts analyzed, focusing on key activities and differences from which GCEP Partners could align. The Brookings Institute and the Chicago Metropolitan Agency for Planning, with support from the Searles Fund at the Chicago Community Trust, spearheaded this initiative with the support of the county board chairs and the mayor of Chicago, creating a timeline and helping to draft the firstever Regional Statement on Economic Cooperation.

#### **Overview of GCEP**

The GCEP is a regional strategic economic development alliance comprising Chicago and the surrounding seven most populous counties, to drive inclusive economic growth. In the first year of this partnership, GCEP has successfully pitched the region to attract and retain businesses, including Chicago-based companies such S&C Electric Company, national companies such as UPSIDE Foods, with headquarters in San Francisco, and international companies, including Ravago, which recently broke ground in Kendall County. The GCEP focuses on promoting the region's many assets, including transportation infrastructure, diverse talent, key industries, and the innovation ecosystem, including universities, incubators, and startups. The partners have focused, as well, on coordinating international engagement including sharing and optimizing resources like market research and asset mapping to achieve greater efficiency and scale.

The initial three year agreement includes the following partners: Cook County Bureau of Economic Development, Choose DuPage, Kane County Development & Community Services Department, Kendall County Government, Lake County Partners, McHenry County Economic Development Corporation, Will County Economic Development Corporation, the City of Chicago, and World Business Chicago as project sponsor.






#### **Pilot Activation Areas**

Initial areas of interest for the Partnership were identified through the discussions between key GCEP stakeholders and World Business Chicago. During the course of these discussions, the following essential service offerings were identified as core competencies:

- WBC business development for pro-Chicagoland decisions;
- WBC Research Center services (e.g., request for information responses and regional asset development);
- WBC Public Sector funding opportunities; and,
- WBC Innovation & Venture programming inclusion.



Among the key deliverables include the Regional Chicagoland Economic Report, an Interactive Regional Asset Map, Letters of Support for Public Sector Investment Opportunities, and Global Strategic Engagements and Inclusion.

## Chicagoland's Economic Landscape Report: Summary & Asset Map

In September 2023, the World Business Chicago Research Center released the Chicagoland's Economic Landscape Report and the first-ever Greater Chicagoland Region Asset Map, an interactive tool highlighting Chicagoland's strengths.



- Innovation Ecosystem: The blend of established industries, startups, universities, and top-tier research institutions underscores Chicagoland's unique tech identity, fostering a culture of collaboration and technological advancement.
- Affordability & Global Connectivity: The region offers world-class business infrastructure and a globally connected environment at competitive costs, with real estate and living expenses more affordable than many major coastal metros.





### **Summary of Business Development Opportunities & Economic Impact Profile of Key Wins**

#### The Chicagoland Region's Approach

Three key performance indicators were identified by the GCEP and have shaped the three-year commitment from the surrounding counties for their buy-in and support. In addition to Pro-Chicagoland Decisions and business prospecting leads, there was also a focus on regional connections that were made across county partners to ensure a regional approach to economic development.

The two original deliverables, decided by the GCEP, to occur over the first three-year phase include:

- 1. 500 Regional Leads shared.

In its first year of progress, the GCEP has hit the ground running, with 64 Pro-Chicagoland Decisions in 2023, and 40 regional leads shared between counties. Additionally, the GCEP partnership is working by creating 24 connections between the participating partners and local businesses as these introductions were made to county partners. In a year full of macro-economic uncertainty, this collaboration has proved fruitful and has made economic impact across the region.

The significance to Chicagoland is measurably impressive. Business decisions to relocate or expand in the region directly influenced by GCEP efforts resulted in over \$715 million in worker's earnings and over 8,500 jobs.



#### Direct Jobs Created by GCEP Wins by Sub-Industry




#### **GCEP Total Impact by Industry**



In 2023, GCEP efforts were successful in attracting and retaining manufacturers in the region – highlighting the sustained and growing importance of industry in Chicagoland. Nearly half of the impact resulted from the establishment of Lion Electric's electric vehicle manufacturing center in Will County, with food, medicine, and advanced equipment manufacturers comprising the other half.

However, the indirect impact is felt across industries throughout the region. In addition to jobs directly created in manufacturing, increased demand in the local supply chain created jobs in other manufacturing sub-industries, professional services, and transportation  $\mathcal{E}$  warehousing. An influx of workers also created demand for local services like healthcare, retail, and restaurants.

S&C Electric Company is a global provider of equipment and services for electric power systems. The company specializes in the switching, protection, and control of these systems, and has been an essential part of the electrical grid that brings power to homes and businesses around the world.

Since its inception in the early 1900's, S&C has continued to innovate and champion unique technology to provide protection against power outages. Today, it sells internationally and is an industry leader in best practices for product development.



#### **GCEP** Impact

The company has grown tremendously, with over 2,000 jobs in the Chicagoland region. In order to accommodate this growth, S&C Electric considered expanding out of state. GCEP partners took initiative and identified a 275,000 SF expansion space in Palatine, IL that met the needs of the company. The new facility is expected to create approximately 200 production and engineering jobs, with full occupancy and production startup expected in early 2024.



### DuPage County (Itasca) - SyBridge Technologies

#### **Consolidation and Expansion**

**Company Name:** SyBridge Technologies **Industry:** Manufacturing - Life Sciences **Job Impact:** 50 new jobs and 100 jobs retained in the metro area, supporting 301 indirect jobs and \$46.2 million in earnings for workers.

#### About the Company

SyBridge Technologies is a Michigan-based company that provides value-added design through tooling and molding, as well as manufacturing solutions across a wide range of industries.

Since its inception in 2019, SyBridge Technologies has grown its production capabilities and size as a disruptive innovator in the industry. Due to its presence in the Life Sciences industry, the Chicago region appealed to the company early on, and it opened its Fulton Market location as an initial step. In early 2023, the company shifted its focus and brand identity to becoming a global technologydriven enterprise built on innovation, expertise, and service excellence that leading brands around the

world could trust in this digital age.

#### **GCEP** Impact

With the support of GCEP partners, Choose DuPage led the charge on retention and expansion of this company. Thanks to this initiative, in addition to unveiling a showroom, SyBridge Technologies has decided to relocate its headquarters from Southfield, Michigan and consolidate its Fulton Market location in order to open a location in Itasca. The company will hire and/or relocate (from Michigan) some 50 jobs, in addition to moving 100 employees from the Fulton Market location.







### Kane County (Elgin) - Flender Corporation

#### **Expanding An International Turbine Producer**

**Company Name:** Flender Corporation **Industry:** Manufacturing **Job Impact:** 50 new jobs and 140 jobs retained in the metro area, supporting 334 indirect jobs and \$53 million in earnings for workers.

#### About the Company

Flender Corporation is a leading global manufacturer of mechanical gears for industrial applications, including wind turbines. It has a reputation for the highest performance, innovation, quality, and reliability of mechanical and electrical components. Its drive components account for 30 percent of wind turbines in over 33 countries.

Flender has had a presence in Illinois since 1976, with its main headquarters in Bocholt, Germany. Globally, the company has expanded to over 9,000 employees. It has been serving the Americas from its office in Elgin since opening in the Midwest and offers high quality products throughout the region.





#### **GCEP** Impact

With the support of Kane County, GCEP was able to work with the Governor's Office, Illinois Department of Commerce & Economic Opportunity, and Flender Corporation to expand its manufacturing facility for wind and industrial drivetrains - creating 50 new jobs and retaining 140 in the region.



### Kendall County (Montgomery) - Ravago

#### **Global Talent Attracted to Chicagoland**

#### Company Name: Ravago

**Industry:** Manufacturing - Plastic **Job Impact:** 91 new jobs and 59 jobs retained in the metro area, supporting 351 indirect jobs and \$43.5 million in earnings for workers.



#### About the Company

Ravago is a Belgian based plastic-producing company with headquarters in Luxembourg. The company is active in polymer and chemical distribution, building materials, recycling and compounding of plastic.

Ravago was founded in the 1960's with the purpose of recycling production waste from the plastics producing petrochemical companies. It quickly became an innovator in the space and expanded globally.

#### GCEP Impact

GCEP partners brought together community and workforce resources and assisted with incentives to attract Ravago in 2023. Ravago committed to developing its 204-acre Midwest distribution center in Montgomery, IL, bringing 150 jobs to the region (including a retention of 40). The Ravago groundbreaking occurred on October 18, 2023.



### Lake County (Waukegan) - Henry Broch Foods

#### **Expanding and Retaining Legacy Brands**

**Company Name:** Henry Broch Foods **Industry:** Manufacturing - Food and Beverage **Job Impact:** 150 new jobs and 250 jobs retained in the metro area, supporting 1,049 indirect jobs and \$118.6 million in earnings for workers.

#### About the Company

Henry Broch Foods is one of the largest U.S.based international food ingredient, processing and co-packing companies in the world. The company sources quality natural ingredients from growers, and its suppliers produce vegetables, fruits, herbs, spices, and natural colors that have been concentrated, dehydrated, extracted, or pasteurized.

Henry Broch Foods has a long history in Lake County, and especially in Waukegan. This familyowned company was founded in 1941 and has expanded rapidly since its inception. Today, it is a global-facing Chicagoland company and one that will remain in the region.





#### **GCEP** Impact

GCEP partner, Lake County Partners led the charge on working closely with the company's leadership to help it expand its existing Waukegan Headquarters by adding 160,000 square feet of new production, robotic warehousing, and distribution space. Not only is the company retaining 400 existing jobs, it is adding an additional 150 new jobs in Lake County. This project represents a capital investment of nearly \$40 million.



### McHenry County (Crystal Lake) - General Kinematics

#### **Manufacturing Expansion**

**Company Name:** General Kinematics **Industry:** Manufacturing **Job Impact:** 15 direct new jobs, creating 15 indirect jobs and nearly \$2.6 million in total new earnings for workers.

#### About the Company

General Kinematics is the premier manufacturer of vibrating equipment for the processing of bulk materials. It leads in design leadership – with cutting-edge Two-Mass technology, simplified spring reactor systems, and the rugged and reliable equipment construction available. Scores of application tailored technical advancements have propelled General Kinematics' equipment to excel in the most challenging environments.

General Kinematics was founded in 1960, having over six decades of experience in the industry and has seen several years of growth, including acquiring three companies (Cyrus Vibrating Equipment, Tuffman Equipment, and





Foundry Equipment Company) and launching a systems-focused brand.

#### **GCEP** Impact

GCEP Partner, McHenry County Economic Development Corporation, provided support for the completion of a 42,000-square-foot expansion of GK's primary manufacturing space. The new area includes high bay ceilings for 80-ton cranes, additional space for capital equipment, and storage. Including the new addition, General Kinematics' facility now spans 262,000 square feet.



### Will County (Joliet) - Lion Electric

#### EV as a Priority

**Company Name:** The Lion Electric Company **Industry:** Manufacturing **Job Impact:** 1,400 direct new jobs, creating 2,669 indirect jobs and over \$324.6 million in total new earnings for workers.

#### About the Company

The Lion Electric Company is an innovative manufacturer of zero-emission vehicles that designs and manufactures all-electric school buses and urban trucks. It is a leading OEM in transportation electrification in North America, specializing in all components of its supply chain.

Originally started in Canada in 2008, the Lion Electric Company grew quickly in the electric-bus manufacturing space, becoming a leader in the zero-emission niche. After going public in 2020, Lion continued to expand its manufacturing capabilities in North America.





#### **GCEP** Impact

GCEP partner, Will County Center for Economic Development worked closely with the State of Illinois and the Governor's Office to secure Lion Electric's commitment to opening its new Joliet factory earlier this year. With the push to prioritize investing in clean energy through the Climate and Equitable Jobs Act, this was a significant win for the Chicagoland region.



## **Strategic Initiatives & Partnerships**

As a way to further interact with the Greater Chicagoland region, an additional key emphasis in year one of the GCEP was engaging the partners and its respective county stakeholders in events throughout the region; working strategically to secure economic development opportunities.

There were 45 invitations extended to partner members in 2023, which helped lay the foundation for collaboration across the partnership.



#### State Department Visit to the Chicagoland Ecosystem

In August, the GCEP co-hosted Daniel Ricchetti of the US State Department, in a discussion of the opportunities to engage in foreign policy at the local level. Among the highlights were conversations about the region's global leadership in quantum technology and manufacturing innovation. The visit included tours with regional portners of EeroQ, Quantum Hardware, and mHUB (manufacturing and hard tech innovation center). Representatives from Cook County, Lake County Partners, Will County CED, Choose DuPage, McHenry County EDC, and World Business Chicago had the opportunity to pitch on the innovative ecosystem. This included the annual World Business Chicago International Gala, company visits like Valqari (pictured above), and other engagements.



#### GCEP Partners attend the Chicago-Japan Delegation

In October 2023, a 30+ person delegation of business and civic leaders traveled to Osaka, Japan to celebrate the 50-year anniversary of the Osaka-Chicago Sister Cities' international relationship, meeting with 70+ Japanese companies interested in expanding or investing in the United States, strengthening ties with Japanese-based Chicagoland companies.

## **WBC Research Center Initiatives**

Through GCEP, the WBC Research Center tells the region's data-driven economic narrative, including Chicagoland's incredible value proposition. The Research Center leads data analysis for regional partners to better understand and improve upon the region's economy, including identifying growth drivers, opportunities, and risks in key industries. In addition to the Regional Asset Map, key 2023 accomplishments include:

#### **Regional Requests for Information**

In 2023, the WBC Research Center completed over 70 requests for information from county and regional partners. These strategic insights helped attract businesses and informed economic and community development tactics - deliverables ranged from macroeconomic data, to economic impact analyses, to industry and supply chain analyses, and more.

#### **GCEP Economic Dashboard**

The economic dashboard shares up-to-date economic indicators for the Chicago metropolitan area. The dashboard describes the size of the Chicagoland regions economy, how the region compares to selected leading metros, and continued improvement over pandemic-related slowdowns.

#### **Regional Collaboration**

In 2023, the WBC Research Center was honored with the Council for Community and Economic Research Community, Economic, and Workforce Research Award for fostering collaborative community and regional initiatives with the Greater Chicagoland Economic Partnership. Already a trusted information resource for the Chicagoland area, the WBC Research Center leveraged its analytical capacity to align county partners and foster cooperation based on shared regional data. This collaboration drove the development of a shared baseline for future analysis and economic development strategy.



## **Public Sector Funding Opportunities**

Public sector funding opportunities was a key activation area identified by GCEP partners. In support of this work, the Public Sector Investment Strategy (PSIS) team from World Business Chicago provides insights and further information about Federal funding opportunities. These initiatives have been selected to competitively position the region for additional federal funding.

One of the regional opportunities the PSIS team spearheaded through the GCEP included the Clean Tech Economy Coalition's proposal for the Department of Energy's Manufacture of Advanced Key Energy Infrastructure Technologies Prize (MAKE IT) under the Strategies Track.

The partnership pledged its support for this initiative, providing a GCEP letter of support under the guidance and strategy of the PSIS team. This project has been led by mHUB Chicago, a center for physical product development and innovation, and will establish a clean technology manufacturing cluster in the greater Chicago region, designed to lead the country in commercialization of clean energy technologies and drive grid resilience and equitable economic growth. mHUB was awarded the Phase 1 Strategies Track grant, and upcoming work and strategy with GCEP will be done to finalize a concept map for a grid modernization manufacturing facility. Key funding mechanisms that opened new opportunities in 2023–with more expected in 2024– include:

- CHIPS and Science Act (CHIPS): Designed to boost US competitiveness, innovation, and national security; supports investments in domestic semiconductor manufacturing, R&D and commercialization of new technologies, and creation of regional tech hubs.
- Inflation Reduction Act (IRA): Aims to build a new clean energy economy and address the primary drivers of climate change, while creating good-paying jobs and promoting environmental justice.
- Infrastructure Investment and Jobs Act (IIJA): Supports opportunities to enhance infrastructure, expand access to clean drinking water, and promote high-speed internet access, while advancing environmental justice and investing in underserved communities.





### **Innovation & Venture Collaboration**

World Business Chicago's Innovation & Venture team has expanded its primary programming to engage the greater Chicagoland community, including:

- Two Chicago Venture Summits: 2,000+ startups, investors, and sector executives attended Chicago Venture Summits

   Future-of-Food (May 2023) and Future-of-Climate-Tech (October 2023), with GCEP as Innovation Sponsor. Cook County President Toni Preckwinkle delivered remarks on behalf of GCEP.
- Regional Trips:

GCEP joined the Innovation & Venture team on regional tours of Fermilab and Argonne National Laboratory, as well as the Chicago Quantum Exchange and mHUB.




## Chicagoland Region: Look Forward

- Innovation and Venture programming and inclusion






#### **Co-Chairs of the GCEP**



GCEP Annual End-of-Year Meeting, held at CineCity Chicago in December 2023



















#### **Red Flag Laws**

Several years ago in response to issues of firearms use the state implemented a law that's commonly referred to as red flag laws. Meaning a person has demonstrated some type of issue – criminal, mental, etc. that indicates that their ability to own and possess a firearm should be denied or suspended for a period of time or revoked.

In Illinois a Firearms Owners Identification (FOID) card is needed to purchase a gun and ammunition. I would like to detail how the Darien Police Department enforces the process.

Below is a graph showing the results of suspended / revoked FOID cards being reported to the Darien Police Department. We monitor and maintain data on suspended / revoked FOID cards since the inception of the program.

There is a significant spike in 2019, which the detective sergeant providing the information believes it can be attributed to measures implemented by the Illinois State Police (ISP) following the Henry Pratt Company shooting in Aurora. The number of suspensions / revocations have been gradually increasing since 2019. This may be to heightened enforcement and increased mental health education and training initiatives.



#### AGENDA MEMO City Council March 18, 2024

#### **ISSUE STATEMENT**

A resolution accepting a proposal from Standard Equipment for the purchase of a new 2023 model Vactor 2100i Fan Sewer Cleaner fleet truck for hydro excavations of buffalo boxes, main line valves, fire hydrant and utility pot holing, storm sewer basin cleaning and storm sewer main line jetting in an amount not to exceed \$548,000.00.

#### **RESOLUTION**

#### BACKGROUND

Throughout the years, the City has utilized the services of a vacuum/jetting truck throughout the City for maintenance and emergency situations of such equipment. The mobile vehicle has more recently been utilized to repair buffalo boxes, (water shut off valves at the exterior of the property) during the meter removal and replacement program. During the lease of the equipment it was utilized to assist in water main breaks and valve removal and replacement as a hydro excavator. Through the course of years prior to the City leasing the equipment, the City Staff has utilized such equipment from our neighboring community as available and or contacted limited vendors to perform emergency services for jetting on storm sewers.

The versatile equipment would allow Staff to operate in a more efficient manner, pending the type of excavation required. For example, the hydro excavation allows Staff to pothole an identified area to confirm a water leak through a non-destructive excavation, compared to a backhoe excavator. This reduces the amount of labor and restoration required especially during an investigative stage. This example only cites one of many as the application applies to sink holes in storm water infrastructure and determining condition of pipes for future replacement.

Today's infrastructure continues to be maintained underground and includes; fiber optic, direct burial, high voltage, secondary voltage cables, gas mains and services and an area with high pressure petroleum pipelines. The City's watermain and storm sewer infrastructure in today's environment tends to compete with the underground space thus exacerbating conventional excavation methods. The equipment will assist in excavations, routine and emergency to safely identify other infrastructure prior to a full excavation and again potentially reduce the limits of the destructive methodology.

The equipment will continue to provide savings through eliminating or reducing excavated spoils, backfill material, hauling, dump expenses and restoration. Further, the equipment will serve as vac-all and jetter to maintain storm sewer infrastructure through an upcoming scheduled catalogue.

Staff has recently completed research on the equipment and has determined that the Vactor is the optimal equipment of choice for the City of Darien. Attached and labeled are additional documents as it relates to the equipment:

The City has maintained a lease with EJ Equipment for the last two years on the **Vac-Con** unit. The unit is also a 2023, model and was made available for purchase to the City. The price of the vactor to the City was \$484,535 and included \$43,350 of rental rebates. A brand new 2024 model with similar components was priced with joint purchasing credits at \$652,261.

The City had engaged with Standard Equipment for a competitive comparison of their version of the vac-all truck, referred to as the **Vactor**. The Staff had met with the representative of Standard to review specifications and pricing of a Vactor truck. Upon review of the research it was determined that the Vactor is the optimal piece of equipment for the City of Darien. The pricing for a new Vactor truck was adjusted to \$550,000 for the FY2024/25 Budget. On February 29, as attached with e-mail correspondence above, a Vactor unit was made available due to a last-minute cancelation. The equipment was valued at \$565,000 and included add-on equipment that he City did not require. Standard Equipment and Staff negotiated that certain add-on equipment would be removed and items that were integral with the cab and chassis would remain. The additional discounting was in an amount of \$17,000, resulting a net cost of \$548,000. Standard Equipment agreed to hold the equipment and pricing until March 19, 2024. Director Gombac updated the City Council at the March 1, 2024 City Council meeting of the opportunity that was provided and that an agenda would be forwarded to City Council for the March 18, 2024, City Council meeting.

In reviewing the FY23/24 Budget with Administrator Vana it was determined that funds were available this year and that the purchase would be made from the following accounts. The FY24/25 Budget was adjusted to remove the line items for the equipment.

Dan,

As a recap we are getting a great opportunity with the truck being presented by Standard Equipment. We are getting all the major system components that we want and many options that we wanted to select all at a discounted price. Standard Equipment has worked with staff to really listen to what we want and are looking for and help guide us through all the options and provided us several different options including building a Vactor which we could have accomplished for the \$550k budgeted price. When the other customer backed out it presented an opportunity for us to secure a truck that had even more options that we had originally thought we could afford given the \$550k price point. Also, was just notified that there is a 3% cost increase from the manufacturers that will go into effect this week (may have already done so) on any new cab and chassis orders).

I am not saying that Vac-Con doesn't build a nice truck or that EJ isn't great to deal with. Quite the opposite is true especially in regards to EJ. City had not dealt with Vac-Con on any purchases to date. We several pieces of equipment from EJ and they have always treated the City very well. With this piece of equipment we just found out more information that really led us to seeking other options that would better suit the City. Long term care and maintenance concerns really played a large factor in this decision. Vac-Con offers units with some of the major system components that we want we just can't get them for the price we are getting the unit from Standard Equipment for. We would have to build it and we see that minimum cost is \$100k higher than we are getting this truck for based on the quote provided by EJ Equipment.

See attached document going over many of the requested items below. A few follow up points not included on that are:

In speaking with a few local Municipalities that have Vactor units is they truly seem to love them.

- They have been referred to as the Cadillac of the Combination Sewer Truck.
- They have stated that the support from Standard Equipment and Vactor and is 2<sup>rd</sup> to none.
- The ability to send people to Streator for both Operator and Mechanic training for **FREE** is a huge benefit (I did put that on my sheet with a note that we may need to budget for travel expense like hotel as it is a 3 day class that is full day but that is something we can discuss further). For the training there is an annual training list that comes out every year and we can sign people up for available classes.
- The Vactor Trucks seem to be very Operator orientated which leads to happy and safer workers
- There seem to be more attention to detail and design with the Vactor Unit.
  - Conversations with Standard Equipment indicate that Vactor has a very large Engineering Department and they spend a lot of time reviewing a cab and chassis before it rolls into the plant to be built. They are ensuring that everything is correct and all options are right.
- Due to being owned by Federal Signal, Vactor has a lot of purchasing power in cab & chassis from the manufacturers. This allows them to have the cab & chassis setup directly from truck manufacturer for their equipment to be mounted/installed. No drilling or welding equipment to the frame of the truck is done after it leaves the truck manufacturer. This allows Vactor to roll a cab & chassis into their assembly plant and have it built in 2 days (working 5-6 stations inside the plant – one on all 3 shifts).
  - Vac-Con bay builds the trucks like how our plow trucks are built. Not that there is anything wrong with this method it just isn't as efficient and there is not as much consistency and there is room for error with this method.

I have attached a customer list provided by Standard of some surrounding Municipalities. This is not all inclusive. They can provide more if needed as well.

#### RULES FOR COMPLIANCE WITH PUBLIC COMMENT REQUIREMENTS OF THE ILLINOIS OPEN MEETINGS ACT

#### I. PURPOSE OF RULES.

The purpose of these Rules is to comply with the requirement of Section 2.06 of the Illinois Open Meetings Act that a public comment section be provided at each meeting subject to the Open Meetings Act.

#### II. DEFINITION OF "PUBLIC BODY" or "BODY."

For purposes of these Rules, the term "Public Body" or "Body" shall mean the City Council, any Committee of the City Council, and any Board and Commission established by the City Council.

#### III. RULES GOVERNING PUBLIC COMMENT.

A. Unless otherwise allowed by a majority vote of the Body, the public comment periods shall be as follows:

1. For the City Council, as set forth on the attached **Agenda template**.

2. For Council committees and advisory committees, at the conclusion of the meeting immediately before adjournment. At the direction of the Body, the floor may be opened for public comment in conjunction with specific agenda items.

B. Individuals seeking to make public comment to the Body shall be formally recognized by the Chair.

C. Individuals addressing the Body shall identify themselves by name, but need not provide their home address.

D. Individuals addressing the Body shall do so by addressing their comments to the Body

itself and shall not turn to address the audience.

E. Public comment time shall be limited to three (3) minutes per person.

F. An individual will be allowed a second opportunity to address the Body only after all other interested persons have addressed the Body and only upon the majority vote of the Body.

G. In the case of a special meeting, public comment will be limited to subject matters germane to the agenda of the special meeting.

#### IV. PUBLIC HEARING REQUIREMENTS.

Additional public comments periods will be allowed as required by law in the case of public hearing, subject to the same time constraints.
