1. CALL TO ORDER The regular meeting of the City Council of the City of Darien was called to order at 7:33 P.M. by Mayor Carmen D. Soldato.

He commented that over 1,000 residents from Darien utilize the College every year.

Mayor Soldato asked Dr. Murphy to consider Darien if the College intended to expand their off-campus facilities.
