#### 1. <u>CALL TO ORDER</u>

The regular meeting of the City Council of the City of Darien was called to order at 7:30 P.M. by Mayor Marchese.

#### 2. **PLEDGE OF ALLEGIANCE**

Mayor Marchese led the Council and audience in the Pledge of Allegiance.

3. **ROLL CALL** — The Roll Call of Aldermen by Clerk Ragona was as follows:

4. <u>DECLARATION OF A QUORUM</u> – There being seven aldermen present, Mayor Marchese declared a quorum.

#### 5. **QUESTIONS, COMMENTS AND ANNOUNCEMENTS – GENERAL**

Laura Chucri, resident and owner of rental properties in Darien, shared concerns with short-term rental ordinance restricting rental to 30 days or more. Mayor Marchese explained issues encountered with shorter timeframe that necessitated ordinance change. She commented on pending lawsuit regarding Village of Glen Ellyn's ban against short-term rentals.

Quentin (Tracy) Sims voiced his support for e-bike ordinance and shared dangerous e-bike incident on Clarendon Hills & Plainfield Roads. He attended Police Committee Meeting and provided incident information for future reference.

Nick Darien, 8400 block of Sandalwood Court, applauded City for e-bike Ordinance. He referenced proposed Ordinance Section 9-10-1 and suggested adding stipulation that those under 16 years of age cannot operate a Class 3 low-speed electric bicycle.

Joe Bosch voiced safety concerns with e-bikes ridden on sidewalks/roads at 25-30 mph and going across lawns with no respect for property.

Heather Conroy commented on 30-day rental restriction, inability for Ward 6 Alderman Gustafson to participate in City Council Meeting remotely, and Chestnut Court TIF. Administrator Vana and Mayor Marchese responded.

Steve Kimmey shared need for stronger e-bike Ordinance, similar to Elk Grove Village; he felt younger bikers lacked user education.

#### 7. **RECEIVING OF COMMUNICATIONS**

Alderman Schauer received communication from Debra Markovich, 8100 block of Chapman Court, regarding noise and construction ordinances. Deputy Chief Norton responded; residents should call 911, so Police can respond to the situation. Alderman Leganski and Alderwoman Sullivan commented.

Alderman Kenny noted receipt of communication from Ms. Conroy; he extended invite for her to attend City Council Meeting.

#### Alderwoman Sullivan...

...received communication from Kelly Glisan regarding excessive telemarketing signage. She contacted Municipal Services; signs posted illegally on City right-of-ways will be removed.

...made a general statement regarding communication; she stressed the importance of going directly to the source for information (i.e. attend City Council Meeting, read information on City's website, contact City Hall, Police Department, Darien Park District & Indian Prairie Public Library). She commented that Nextdoor & Patch can be misleading.

#### 8. MAYORS REPORT

Mayor Marchese provided an update on Summer Internship Program. Over the course of six weeks three students from Hinsdale South High School met with City personnel, Police Department, and elected officials from the state, county and local levels to gain a deeper appreciation of how government bodies operate, collaborate and serve the public. As a culmination of their experience, students are preparing a "Capstone" project, which will be presented to City Council, District #86 Administration and Board of Education.

Mayor Marchese thanked all those who took time to participate. He looks forward to expanding program to include Downers Grove South High School students.

#### **ISSUE STATEMENT**

A motion accepting the expenditure of Equitable Sharing Funds to purchase hardware and services from Flock Safety for six Automatic License Plate Readers (ALPR) in the amount of \$38,900.00.

#### **BACKUP**

#### **BACKGROUND/HISTORY**

The City began using Flock Safety's ALPR in April of 2024. The initial deployment consisted of ten camera installations at strategic locations within the City. For over a year, officers have used the product and have begun to utilize the tool in crime detection, prevention, and investigation.

The additional cameras will aid police to further and more completely monitor motorists entering and leaving the City who have committed or intend to commit crimes within our community.

This agreement is to expand our ALPR network by adding six more cameras to the community at five locations. The initial cost for installation and service will be \$19,600, followed by an annual cost of \$19,300 (year two).

Previously, staff have explored other options for ALPR, and Flock Safety was chosen. Keeping with the continuity of Flock Safety, no other company was explored. Each company uses its proprietary software for monitoring and detection. It would be cumbersome and prohibitive to deploy other ALPR at this point.

The federal requirement for using vendors is vendors must be vetted through System for Award Management (SAM.gov). The company is a qualified vendor.

The Darien Police Department is a proud participant in the United States Department of Justice and the United States Department of Treasury Equitable Sharing Program for State and Local Law Enforcement Agencies. For the last several years the Darien Police Department has participated in federal task forces whose goal is to stem the flow of illegal narcotics into the Chicago metropolitan area which is one of the major hubs for illegal narcotics coming into the United States. It is the goal of this program to not only cut off the flow of illegal narcotics into the area, but to take away and use the tools, proceeds and property derived from any criminal activity against the offenders. These seized tools, proceeds and property are ultimately a deterrent to criminal activity and an enhancement to law enforcement. Under the Guidelines of the Equitable Sharing

Program, the funds received cannot be used to replace or supplant the police department's regularly budgeted monies but augment the police budget. These seized monies may only be used by the police department in order to augment the police budget. This purchase meets the Guidelines of the Equitable Sharing Program and will provide an important tool for the police department that otherwise would not be available without participation in the Equitable Sharing Program. The cash balance of this fund is \$68,597.55 as of July 14, 2025.

The City's EOP plan was last updated in early 2023. There have been many required changes made to the Illinois Emergency Management Agency's Administrative Code 301 EOP section. Staff recommends hiring Keith Fontana to keep the City of Darien's EOP in compliance with the state.

Mary Pratt, MP Preparedness Consulting was previously hired in 2022 and continued work with the City to update the EOP. Mary's services were discontinued in early 2023. Staff has sought a replacement for MP Preparedness, but were unable to find one to fill the position. Responses were either astronomical in cost and/or nowhere near what we were looking for from a local emergency manager perspective. Keith came as recommended by other contacts within the emergency management realm.

In 2022, the City's Emergency Operations Plan (EOP) was successfully updated and finalized based on guidance and estimates provided by MP Preparedness, which projected the update process would require approximately 220 hours of work.

As of mid-2025, the State of Illinois is in a period of transition regarding emergency planning requirements. Updates to the State's EOP expectations are anticipated but have not yet been announced. Once these changes are formalized, the City's EOP will need to be reviewed and updated accordingly to remain compliant with state guidance and best practices.

#### **Responsibility and Coordination**

Mr. Keith Fontana has been designated to lead the forthcoming updates to the City's EOP. In this role, he will:

- Attend Local Emergency Manager Committee (LEMC) meetings facilitated by the DuPage County Office of Emergency Management and Homeland Security (OHSEM).
- Participate in additional meetings as needed to engage local partners, gather new requirements, and conduct research and documentation related to the evolving State guidance.
- Develop and maintain relationships with local, county, state, and federal emergency management stakeholders to ensure effective collaboration, alignment of expectations, and resolution of any concerns.

#### **Disaster Response Support**

In the event of a significant disaster or emergency, Mr. Fontana may be called upon to support City operations by assisting in coordination efforts, advising staff, and facilitating resource management.

#### **Compensation and Reporting**

Mr. Fontana is employed on a part-time basis at a rate of \$55 per hour. He will:

- Submit monthly invoices for services rendered.
- Maintain regular communication with the Deputy Chief of Operations, providing biweekly updates that include:
  - A summary of completed tasks
  - o Progress on in-process items
  - o Identification of upcoming goals and objectives

This engagement will remain dynamic, evolving with the direction provided by the State of Illinois and in alignment with the City's preparedness and emergency management priorities.

#### **ISSUE STATEMENT**

A Motion to Approve an Ordinance Amending Chapter 10 "BICYCLES, LOW-SPEED ELECTRIC BICYCLES AND PERSONAL MOBILITY DEVICES" to Title 9 of the "TRAFFIC REGULATIONS" of the City of Darien City Code.

#### **ORDINANCE**

#### **BACKGROUND/HISTORY**

After debate and discussion to pass the Bicycles Low-Speed Electric Bicycles and Personal Mobility Devices, commonly referred to as the e-bike & e-scooter ordinance we discovered there was an error with Section 9-10-3, paragraph (K). The error had to do with the age of individuals who can lawfully ride an e-bike and an e-scooter. The correct verbiage should be:

#### (K) Age Restrictions

- 1. A person may not operate a Class 3 low-speed electric bicycle unless he or she is 16 years of age or older.
- 2. A person may not operate a low speed scooter unless he or she is 18 years of age or older.

#### STAFF RECOMMENDATION

Staff recommends the approval of the corrected language to paragraph K of Chapter 10 "BICYCLES, LOW-SPEED ELECTRIC BICYCLES AND PERSONAL MOBILITY DEVICES" to Title 9 of the "TRAFFIC REGULATIONS" of the City of Darien City Code.

#### 9-10-1 **DEFINITION**

#### **BICYCLE**

Every device propelled by human power upon which any person may ride, having two (2) tandem wheels except scooters and similar devices.

#### LOW-SPEED ELECTRIC BICYCLE

A bicycle equipped with fully operable pedals and an electric motor of less than 750 watts that meets the requirements of one of the following classes:

- Class 1 low-speed electric bicycle means a low-speed electric bicycle equipped with a motor that provides assistance only when the rider is pedaling and that ceases to provide assistance when the bicycle reaches a speed of 20 miles per hour.
- Class 2 low-speed electric bicycle" means a low-speed electric bicycle equipped with a motor that may be used exclusively to propel the bicycle and that is not capable of providing assistance when the bicycle reaches a speed of 20 miles per hour.
- Class 3 low-speed electric bicycle means a low-speed electric bicycle equipped with a motor that provides assistance only when the rider is pedaling and that ceases to provide assistance when the bicycle reaches a speed of 28 miles per hour.

|--|

A "low-speed electric bicycle" is not a moped or a motor driven cycle. Illinois Vehicle Code (625 ILCS 5/1-140.10).

### PERSONAL (micromobility) MOBILITY DEVICE

An electric-powered or electric-assisted device designed to transport only one person with an electric propulsion system of less than 750 watts and that limits the maximum speed of the device to twenty (20) miles per hour or less, such as a motorized or motor-assisted scooter, motorized or motor-assisted skateboard, or any other similar devices. Illinois Vehicle Code 625 ILCS 5/1-140.11 describes a low-speed electric scooter as a device weighing less than 100 pounds, with 2 or 3 wheels, handlebars and a floorboard that can be stood upon while riding, that is solely powered by an electric motor and human power and whose maximum speed, with or without human propulsion, is no more than 10 miles per hour. "Low-speed electric scooter" does not include a moped or motor-driven cycle.

#### 9-10-2 OBEDIENCE TO TRAFFIC-CONTROL DEVICES:

Any person operating a bicycle shall obey the instructions of official traffic signals, signs and other control devices applicable to vehicles unless otherwise directed by a police officer.

Wherever authorized signs are erected indicating that no right or left or "U" turn is permitted, no person operating a bicycle shall disobey the direction of any such sign, except when such person dismounts from the bicycle to make any such turn, in which event such person shall then obey the regulations applicable to pedestrians.

## 9-10-3 OPERATION OF BICYCLES, LOW-SPEED ELECTRIC BICYCLES, AND PERSONAL MOBILITY DEVICES:

- (A) Riding on Bicycles, low-speed electric bicycles, and personal mobility devices
  - 1. A person operating a bicycle or low-speed electric bicycle shall not ride other than upon or astride the permanent and regular seat attached thereto.
  - 2. A person operating a bicycle or low-speed electric bicycle shall not carry any other person or persons upon such bicycle or low-speed electric bicycle other than upon a firmly attached and regular seat designed and intended for such purpose.
  - 3. No bicycle, low-speed electric bicycle, or personal mobility device shall be used to carry more than one (1) person unless specifically designed for more than one (1) person.
- (B) Speed

No person shall operate a bicycle, low-speed electric bicycle, or personal mobility device at a speed greater than is reasonable and prudent under the conditions then existing, or in any case in excess of 20 MPH.

(C) Riding on Right

Every person operating a bicycle or low-speed electric bicycle upon a public street or roadway shall ride as near to the right side thereof as practicable, exercising due care when passing a standing vehicle or one proceeding in the same direction.

(D) Emerging from Alley or Driveway

The operator of a bicycle, low-speed electric bicycle, or personal mobility device emerging from an alley, driveway or building shall, upon approaching a sidewalk or sidewalk area extending across any alleyway, yield the right of way to all pedestrians approaching on said sidewalk area and upon entering the public street or roadway shall yield the right of way to all vehicles approaching on said street or roadway.

(E) Duty to Yield

Whenever a person is riding a bicycle or personal mobility device upon a sidewalk, such person shall yield the right of way to any pedestrian, and shall give an appropriate signal clearly audible to such pedestrian.

(F) Clinging to Vehicles

No person riding upon any bicycle, low-speed electric bicycle, or personal mobility device shall attach said bicycle, low-speed electric bicycle, or personal mobility device, or himself, by clinging or otherwise, to any other vehicle.

(G) Riding in a Group

Persons operating bicycles, low-speed electric bicycles, or personal mobility devices shall ride in single file.

(H) Carrying Articles

The use of handheld cell phones, or similar devices, while operating a low speed electric bike and/or personal mobility device is prohibited. The operator of a low speed electric bike and/or personal mobility device with handlebars shall keep both hands on the handlebars at all times.

(I) Parking

No person shall park a bicycle, low-speed electric bicycle, or personal mobility device upon a public street or roadway, nor upon a sidewalk except as follows:

- 1. On a sidewalk in a rack designed and installed for that purpose.
- 2. On a sidewalk adjacent to a building with the bicycle, low-speed electric bicycle, or personal mobility device resting on its own standard, provided no part of the bicycle, low-speed electric bicycle, or personal mobility device shall be more than two and one-half feet (2 1/2') from the adjacent building.
- (J) Other Vehicles Prohibited

Electric bicycles other than low speed electric bicycles, or devices that do not meet the definition of personal mobility devices as defined in Section 9-10-1 due to being equipped with a motor of 750 watts or more, or capable of a maximum speed in excess of twenty (20) miles per hour, shall not be permitted to be operated on any public right-of-way or on any other public property within the City to include sidewalks and trails.

- (K) Age Restrictions
  - 1. A person may not operate a Class 3 low-speed electric bicycle unless he or she is 16 years of age or older.
  - 2. A person may not operate a low speed scooter unless he or she is 18 years of age or older.

#### 9-10-4: LOCATION RESTRICTIONS:

(A) Bicycles

Bicycles, other than low-speed electric bicycles, may be operated on any street, sidewalk, or trail in the City.

(B) Low-Speed Electric Bicycles

Low-speed electric bicycles shall be operated only on the street. No person shall operate a low-speed electric bicycle on any sidewalk, or trail within the City.

(C) Personal Mobility Devices

Personal Mobility Devices may be operated on any sidewalk or trail in the City. No person shall operate a personal mobility device on any public street, roadway, or alley within the City, except where necessary to cross a street at a designated crosswalk.

#### 9-10-5: EQUIPMENT:

(A) Lamps and Reflectors

Every bicycle, low-speed electric bicycle and personal mobility device when in use at nighttime shall be equipped with a lamp on the front which shall emit a white light visible from a distance of at least five hundred feet (500') to the front and with a red reflector on the rear which shall be visible from all distances from fifty feet (50') to three hundred feet (300') to the rear when directly in front of lawful upper beams of headlamps on a motor vehicle. A lamp emitting a red light visible from a distance of five hundred feet (500') to the rear may be used in addition to the red reflector.

(B) Brakes

Every bicycle, low-speed electric bicycle and personal mobility device shall be equipped with a brake which will enable the operator to make the braked wheel skid on a dry, level, clean pavement.

(C) Alterations to Low-Speed Electric Bicycle or Personal Mobility Device
No person shall knowingly modify a low-speed electric bicycle or personal mobility
device to change the manufacturer's speed capability. No person shall operate an altered
low-speed electric bicycle or personal mobility device that allows the low-speed electric
bicycle or personal mobility device to travel faster than the manufacturer's speed
capability.

#### 9-10-6: DUTY OF PARENT OR GUARDIAN:

It shall be unlawful for any parent or guardian to permit any minor child of which they are a parent or guardian to violate any provisions of this chapter.

#### 9-10-7: APPLICATION OF CHAPTER:

The provisions of this Chapter shall apply whenever a bicycle, low-speed electric bicycle, or personal mobility device is operated upon any public street, roadway, alley, sidewalk or other public way within the City.

#### **ISSUE STATEMENT**

A motion authorizing the purchase and installation of pre-wet/anti icing equipment and hydraulic controls from Lindco Equipment Sales, in an amount not to exceed \$100,367, as per the unit prices attached and labeled as **Exhibit A**.

#### **BACKGROUND/HISTORY**

The Municipal Services Department currently utilizes two distinct snow and ice control strategies that employ chemical freezing point depressants: **de-icing** and **anti-icing**.

**De-icing** operations are performed to break the bond of already-adhered snow and ice on the roadway. These operations are typically initiated only after one inch (1") or more of snow has accumulated and bonded to the road surface.

**Anti-icing** operations are conducted in advance of a storm to prevent the formation of bonded snow and ice, making subsequent removal easier. The benefits of anti-icing are considerable. Pretreating surfaces with anti-icing products before a storm can increase winter roadway safety, reduce the cost and effort of post-storm cleanup, minimize deicer usage, and lessen environmental and property impacts.

The department began using various anti-icing and de-icing compounds in 2017, initially applying them only on mainline roads. After evaluating available options, the department has determined that Beet Heat Super Severe is the optimal product currently available to meet the needs of the City of Darien.

Additionally, the department has implemented real-time road sensors and cameras throughout the city to efficiently calibrate onboard vehicle equipment for optimal additive application during weather events. In summary, the technology and equipment support the effective use of anti-icing agents, rock salt, and de-icing additives to maintain safe roadways during winter storm conditions. As part of ongoing improvements, the department is expanding anti-icing services to include secondary roadways for the 2025/26 winter season.

The FY25/26 Budget includes funding for the following equipment upgrades related to anti-icing and de-icing operations:

#### Units 101, 103, 106, 109, 110

- Hydraulic Pump Upgrades
- Cab Controls
- Spray Bar Equipment for Anti-Icing and De-Icing

#### **Units 105 and 108**

- Over-the-Tailgate Liquid Tanks
- Cab Controls
- De-Icing Spray Bars

Staff secured two competitive quotes for the purchase and installation of the required equipment. The cost breakdowns are included and labeled as **Attachment A**.

Mike,

I hope all is well. Checking in with you regarding the recent proposals that we have received. These were quotes that we had originally had Monroe and Force come out and look at over the winter to ensure we were getting accurate pricing and getting the product that we wanted/needed. When I got the prices back in May they had substantially increased and subsequently we needed to get a secondary quote on this. The quotes for the over the tailgate liquid tanks were pretty much in line with what they were quoted back in the winter, however, the quotes for the 5 trucks for the spray bars increased by pretty much 50%. That is even after we removed the PreCise GPS, which went from being supplied as part of the quote to the City having to supply. That type of price increase is not in line with any typical price increases that we experience in the industry. This increase happened in under 4 months, with the original quotes received on 1/24/25 and updated pricing from Monroe sent on 5/19/25. We had even built some additional money in on top of Monroe's quotes and we are still over budget, so we were just blown away.

We are hopeful that you can really provide us with some insight as to why the increases were so dramatic with the equipment? And only on one the types of proposals. Looking forward to hearing back from you very soon.

## RULES FOR COMPLIANCE WITH PUBLIC COMMENT REQUIREMENTS OF THE ILLINOIS OPEN MEETINGS ACT

#### I. PURPOSE OF RULES.

The purpose of these Rules is to comply with the requirement of Section 2.06 of the Illinois

Open Meetings Act that a public comment section be provided at each meeting subject to the Open

Meetings Act.

#### II. DEFINITION OF "PUBLIC BODY" or "BODY."

For purposes of these Rules, the term "Public Body" or "Body" shall mean the City Council, any Committee of the City Council, and any Board and Commission established by the City Council.

#### III. RULES GOVERNING PUBLIC COMMENT.

- A. Unless otherwise allowed by a majority vote of the Body, the public comment periods shall be as follows:
  - 1. For the City Council, as set forth on the attached **Agenda template**.
  - 2. For Council committees and advisory committees, at the conclusion of the meeting immediately before adjournment. At the direction of the Body, the floor may be opened for public comment in conjunction with specific agenda items.
- B. Individuals seeking to make public comment to the Body shall be formally recognized by the Chair.
- C. Individuals addressing the Body shall identify themselves by name, but need not provide their home address.
  - D. Individuals addressing the Body shall do so by addressing their comments to the Body

itself and shall not turn to address the audience.

- E. Public comment time shall be limited to three (3) minutes per person.
- F. An individual will be allowed a second opportunity to address the Body only after all other interested persons have addressed the Body and only upon the majority vote of the Body.
- G. In the case of a special meeting, public comment will be limited to subject matters germane to the agenda of the special meeting.

#### IV. PUBLIC HEARING REQUIREMENTS.

Additional public comments periods will be allowed as required by law in the case of public hearing, subject to the same time constraints.

# Policy establishing guidelines pertaining to the adoption of a requested ceremonial document, proclamation, and/or resolution supporting the activities or endeavors of the requestor

#### I. Purpose

The purpose of this policy is to establish guidelines for the issuance of ceremonial documents, proclamations, and supporting resolutions by the City of Darien. These documents are strictly honorary and do not carry any legislative or legal significance. The issuance of ceremonial documents, proclamations and supporting resolutions recognize and celebrate significant achievements, milestones, and events within the City of Darien.

#### **II.Policy**

It is the policy of the City Council to consider requests for ceremonial documents, proclamations, and supporting resolutions only when:

- 1. such issuance positively and directly impacts the Darien community, pertain to a Darien event,person, organization, or cause with local implications
- 2. such issuance proclaims certain events or causes when such proclamations pertain to a Darienevent, person, organization, or cause with direct local implications at determined by the city.
  - a. <u>Examples of acceptable recognition include, but is not limited to:</u>

- Matters of public awareness about an issue for a community organization.
- Arts, cultural or historical occasions.
- A commemoration of a specific accomplishment, time, period, or event that impactsDarien residents.
- Recognizing the diverse cultures in Darien
- Recognition of action/service above and beyond the call of duty
- Recognition of extraordinary action or achievement.

#### b. Examples of unacceptable recognition include, but is not limited to:

- Events or organizations with no direct relationship to or location within the corporatelimits of the City of Darien
- Campaigns for events contrary to Darien's policy or the wellbeing of its businesses or residents
- Political, religious or foreign issues not within the immediate responsibility or sphere of influence of the City as determined by the City.
- Anything that may suggest an official city position on a matter under consideration by thecity

All requests for a ceremonial document, proclamation, or a supporting resolution shall be submitted to the Mayor.
